### 2. ADOPTION OF PREVIOUS MINUTES

2.1 The Minutes of the Theme Committee meeting of 19 April 1995 contained in Document A21 were adopted with the amendment that BH Vilakazi be recorded as being present at that meeting.

#### 3. MATTERS ARISING

- 4. PRESENTATION BY MEDIA DEPARTMENT FOR ADVERTISEMENTS
  FOR BLOCKS 7 & 9
- 4.1 The Chairperson reported on the presentation by the advertising agency of the proposed advertisements for Blocks 7 and 9 which had taken place at the Core Group meeting on Wednesday 19 April, the Minutes of that meeting being contained in Document A21. He reported that because the ANC expressed concerns about the advertisements and had not yet discussed this issue, it had been agreed that the presentation should be made to the Theme Committee for comment.
- 4.2 A member of the CA Media Department presented the proposed advertisement on the flag for discussion by the Theme Committee.

It was agreed that the advertising agency should take into account the concept that the CA is a process of a new beginning and this should be a guide for formulating the advertisements. It was further agreed that there should be separate advertisements for each of the issues in these Blocks.

The media department agreed to take into account the comments made by the party representatives at the Core Group meeting of 19 April and the Theme Committee when reformulating the advertisements, together with the advertising agency.

#### 5. FINALISING DRAFT REPORT FOR BLOCK 2

- 5.1 The Technical Advisors reported on the amendments which the Theme Committee had instructed to be made to the Draft Report for Block 2 contained in Document A20 (Extra Documentation) which had been tabled at the Theme Committee Meeting of 19 April 1995. The following amendments had been made:
  - (a) Note on Page 13 under Part Two had been reformulated

as follows:

"Not all parties have dealt with the agenda items referred to below in the same detail. The parties have agreed that no significance should be attached to this."

It was agreed that this formulation was accepted.

(b) With regard to the second paragraph on Page 14, Point B)1, the Technical Advisors tabled a reformulated paragraph which attempted to include the aspects of affirmative action, equal access and an element of reasonableness.

It was agreed that the following formulation should be included in the Report namely:

"-substantive equality, seen to imply the sanctioning, for a reasonable period, of measures designed to improve the situation of those disadvantaged by past discrimination (now outlawed), in order to enable such persons to achieve the full and equal enjoyment of their legal rights (as in section 8 (3) (a) of the 1993 Constitution). Substantive equality also implies the sanctioning, for a reasonable period, of measures designed to provide equal access to opportunities to those disadvantaged by unfair discrimination."

It was further agreed that the above formulation would replace Non-Contentious Point 3 on Page 21 in the Analytical Survey.

(c) It was confirmed that the item <u>Discussion</u> under Public Submissions on Pages 50 and 51 would be deleted from the report, as had been agreed at the Theme Committee meeting of 19 April 1995.

It was agreed that Theme Committee One's Report on Block 2 was approved for submission to the Constitutional Committee.

#### 6. TABLING AND DISCUSSION OF PARTY SUBMISSIONS

6.1 It was agreed that this item should stand over until the next Theme Committee meeting.

- 1. OPENING
- 1.1 The meeting was opened by the Chairperson at 11h15.
- 2. PRESENTATION BY ADVERTISING AGENCY AND FINALISATION OF ADVERTISEMENTS FOR BLOCKS 7 AND 9
- 2.1 The advertising agency reported that, having taken into account the concerns raised and comments made by the Core Group and the Theme Committee, it had reformulated the advertisements on the flag and language issues and would be presenting proposals on the advertisements on seats of government and the name of the country.

#### 2.2 Flag

Three print advertisements were presented by the advertising agency.

It was noted that the ACDP, DP, FF and NP preferred the advertisement that was originally presented by the advertising agency at the Core Group meeting on 19 April 1995 and Theme Committee meeting on 20 April 1995. However, it was agreed that to avoid

delaying the process further the first advertisement presented at this meeting reading "What will the country's new flag look like...You decide" is acceptable in terms of the Theme Committee decision.

### 2.3 Language

A print advertisement was presented. It was agreed that this was acceptable with the amendment that it should read "What should our country's official language/s be?"

Two radio advertisements were presented and it was agreed that the first advertisement which lists the different languages in alphabetical order is acceptable.

#### 2.4 Seats of Government

Two print advertisements were presented. It was agreed that the advertisement should read "Where should the seat of Parliament sit".

### 2.5 Name

The advertising agency requested proposals for the advertisement on the issue of the name of the country.

It was agreed that the advertisement should be kept as simple and as general as possible.

#### 2.6 Press Statement

The Media Department requested feedback from the Core Group as to whether a press statement could be released.

It was decided that a press statement would be released inviting public submissions on the above issues.

# ANC SUBMISSION

### Supremacy of the Constitution

Constitutional Assembly
Submission to Theme Committee 1
Block 3

### **Guiding principles**

- 1. The ANC submits that the following guiding principles are relevant for the question of the supremacy of the constitution and should be reflected in the context in which the supremacy of the constitution is formulated:
  - 1.1 The character of the state shall be a multi-party democratic state based upon democratic majority rule.
  - 1.2 There shall be a bill of rights guaranteeing all accepted human rights including socio-economic right and which shall, where appropriate, be applicable against all sources of power.
  - 1.3 Parliament shall, subject to the Constitution, be the supreme law maker, and the expression of the will of the people. The executive will be accountable to it.
  - 1.4 Parliament shall not be limited in its capacity to legislate so as to address the legacy of the past including such issues as land restoration, re-distribution, and affirmative action.
  - 1.5 Separation of Powers between the organs of state shall be provided for in a manner consistent with the accountability of the executive to Parliament.
  - 1.6 All provisions of the final constitution shall be capable of amendment subject only to the constitutional prescribed majorities and procedures.

#### The democratic constitutional state

25/3

- The South African state should have the character of being a democratic constitutional state expressing the balance between democratism and constitutionalism.
- 3. The concept of the democratic constitutional state¹should be a normative guide and not a mere political programme, and should in an harmonious way encompass the following:

<sup>1.</sup> To be included at least in the Preamble of the Constitution

- 3.1 The principle of democracy: The right of the people of South Africa to exercise state power through the vote as well as state organs and institutions.
- 3.2 The principle of constitutionalism: The national lawgiver (Parliament) should be bound by the Constitution except and in so far as the Constitution may be amended in the prescribed way, whilst the executive and judiciary should be bound by written and unwritten law.<sup>2</sup>
- 4. It follows from 3 that the principle of constitutionalism should be formulated in the context of, and will be influenced by:
  - 4.1 The doctrine of the separation of powers, and
  - 4.2 a fair balance between rigidity and elasticity regarding amendment of different parts of the constitution.

#### The harmonisation of democratism and constitutionalism

- 5. The central problem which the Constitution should solve is the apparent antinomous relation between freedom and equality. Whilst the idea of freedom eventually leads to constitutionalism in the sense of <sup>3</sup> "limited government", the idea of equality is the point of departure of democratism.
- 6. Extreme constitutionalism may give rise to the fear that the exercise of legitimate democratic powers of the people may be subjected to unacceptable and inappropriate limits.4
- 7. In the same way democracy unconstrained by rules guaranteeing equality of citizenship and a fair contest between parties may lead to the arbitrary exercise of state power and anarchic conditions.

It follows that all organs of state at all levels of government are to be bound by the constitution, including Parliament, but only Parliament may amend the Constitution in the prescribed way.

<sup>&</sup>lt;sup>3</sup> As in the constitutional history of the USA.

Sometimes more strongly expressed in the terms that extreme constitutionalism, or "limited government", may be an elitist orientation discourse technique to transcribe an anti-democratic attempt. Giving too much weight to, or over-stating, the supremacy of the constitution may be used to make highly relevant democratic/political questions appear as legal/constitutional questions and thus as unpolitical questions. These political questions are thus restylised and relegated to the legal-scientific sphere, where non-elected experts decide.

- 8. The solution for a moderated constitutionalism and democratism should be sought along the following lines:
  - 8.1 Democracy should be seen as the supremacy of the people through the supremacy of law/the constitution: the idea of democratic constitutionalism. There should be no democracy without constitutionalism, and no constitutionalism without democracy.
  - 8.2 Constitutionalism should be legitimate, and it is legitimate when it is seen against the background of democratic law-making and the democratic law-making and the democratic system of responsible and accountable government.
  - 8.3 The distinction between judicial and political questions which is required for an unacceptable statement of the supremacy of the constitution should be made within the context of the basically undivided unity of law-making and politics in a system of democratic governance.
  - 8.4 The supremacy of the Constitution could accordingly and against this back-ground be seen as meaning that democratic decisions should, with regard to material content and procedure, only be legally possible within the limits set by the Constitution, and thus in accordance with the Constitution.
  - 8.5 The supremacy of the constitution should not be a system against the state, but it should be a system for the democratic state, to guard against the state degenerating into anarchy, arbitrariness and illegality, without a framework of rules. Such a state would undermine democracy and democratic practices.

### The role of the judiciary

- 9. It follows from the above that the underlying assumption in Constituonal Principle XXIII should be accounted for in the final constitution, i.e. that the judiciary should not assume a legislative role in the sense of having to decide on the desirability or necessity of legislative.
- 10. The judicial determination of the constitutionality of legislation should be restricted to establish the formal and material legal compatibility of national or provincial legislation with the Constitution, or the compatibility of provincial legislation with other national legislation, and not the political desirability of the same.


