# DRAFT MINUTES OF THE MEETING OF THE NEGOTIATING COUNCIL HELD AT 19H30 ON TUESDAY 27 MAY 1993 AT THE WORLD TRADE CENTRE

PRESENT: See Addendum A

#### 1. Moment of Prayer/Meditation

A moment of prayer/mediation was observed by all members.

#### 2. Welcome and Attendance

- 2.1 The participants were welcomed.
- 2.2 An appeal was made from the Chair for all participants to conduct the debate and discussion with the dignity, responsibility and reasonability befitting the Negotiating Council. This would ensure that the negotiating process remained constructive.
- 2.3 It was agreed that one participant from each delegation be afforded the opportunity to speak, limiting their input to five minutes. This did not apply to Mr Kriel from the SA Government delegation who would be presenting the facts from the side of the SA Government. After this input, questions of clarity would be allowed, following which would be an opportunity for debate and discussion.

#### 3. Ratification of the Agenda

The agenda was ratified with no amendments.

### 4. The Events Around the Arrests of PAC Members

- 4.1 A statement by the Mr Kriel was made.
- 4.2 Questions of clarity followed.
- 4.3 Discussion and debate followed.



- 4.4 The PAC requested a further opportunity to address the meeting. This was agreed to.
- 4.5 After further discussion and the expressing of various views and proposals, it was agreed that the meeting adjourn to allow the Planning Committee to take the issue further and propose a way forward.

    - \* That equipment and goods confiscated and not needed for prosecution actions, be returned as soon as possible.
  - 4.7.2 From the side of the SA Government:
    - \* That the PAC's continuous commitment to violence and their lack of compliance with the resolutions of the Negotiating Forum of 1 April 1993 and any other resolutions on violence passed by the Negotiating Council be addressed immediately.
- 4.8 It was noted that the AVU and the KP objected to the resolution.

- 5.3 The minutes of the meeting of 25 May 1993 were adopted with no amendments.

\* Various applicants had requested and had been granted an extended deadline (till Thursday 27 May 1993) from Administration to submit their completed application forms.

The completed application forms and newspaper survey results will be forwarded to the Sub-Committee for processing. A recommendation will be made to the Planning Committee on Tuesday 1 June 1993, who in turn will submit a recommendation to the Negotiating Council on Tuesday 1 June 1993.

#### 7. Substantive Issues

# 7.1 Receipt of Second and Supplementary Reports of the Technical Committees

#### 7.1.1 Technical Committee on Violence:

- 7.1.1.1 The members of the Technical Committee on Violence were welcomed.
- 7.1.1.2 The Technical Committee presented an overview of their report, including issues to be highlighted or requiring decision/guidance from the Negotiating Council.
- 7.1.1.3 It was noted that due to time constraints, the Technical Committee had not yet addressed all issues.
- 7.1.1.4 Questions of clarity were addressed to the Technical Committee. Discussion and debate followed.
- 7.1.2.5 After discussion it was agreed that:
  - The Technical Committee on Violence be instructed to report to the next meeting of the Negotiating Council on the Conditions that should be Created to Eliminate Violence in accordance with the Resolution on the "Declaration of Intent on the Negotiating Process" adopted by the Negotiating Council on 7 May 1993. In doing so, the Technical Committee should address all issues identified on a comprehensive and holistic basis.
  - Furthermore, that all participants be encouraged to make additional submissions to the Technical Committee in this regard by 12h00 on Monday 31 May 1993.

### 7.1.2 Technical Committee on Constitutional Issues:

- 7.1.2.1 It was agreed to meet in-committee to discuss the proposed composition, as recommended by the Planning Committee, of the Commission on the Delimitation of Regions/States/Provinces.
- 7.1.2.2 Reports were presented by FT Mdlalose and the Sub-Committee on behalf of the Planning Committee.
- 7.1.2.3 After discussion it was agreed to:
  - \* Remove the name of H Ngubane from the proposed list as she was not available, being a delegate to the Negotiating Council;
  - \* Refer the issue of replacing H Ngubane with another woman back to the Planning Committee to submit a recommendation to the meeting of the Negotiating Council on 1 June 1993;
  - \* Encourage participants to submit further recommendations in this regard to the Planning Committee by 12h00 on Monday 31 May 1993;
  - \* Accept the list of 15 names and announce the Commission;
  - \* Formally accept the Resolution by the Planning Committee on the Commission on the Delimitation on Regions/States/Provinces as amended (see Addendum C).
  - \* Give priority to the reports of the Technical Committee on Constitutional Issues on the agenda of the next meeting of the Negotiating Council on 1 June 1993.
- 7.1.2.4 The meeting then met out of committee and formally adopted the above points.

# 7.1.3 Technical Committee on Fundamental Human Rights during the Transition:

7.1.3.1 The members of the Technical Committee on Fundamental Human Rights during the Transition were welcomed.

- 7.1.3.2 It was noted that the request from the Technical Committee to present their report first before all other Technical Committees for logistical reasons, was agreed to.
- 7.1.3.3 The Technical Committee presented an overview of their reports, including issues to be highlighted or requiring decision/guidance from the Negotiating Council. Discussion and debate followed.
- 7.1.3.4 It was agreed that the Technical Committee be mandated to formulate and draft:
  - The Fundamental Rights to be entrenched during the transitional period referred to in paragraphs 5.1 and 5.2 of the second report (excluding those rights referred to in paragraph 7.3 of the third report);
  - \* Various alternative formulations regarding the rights referred to in paragraph 7.3 of the third (supplementary) report; and
- 7.1.3.5 That the Council, accepting in principle the rights mentioned in the first asterisk above, considers and deals with the report when such a draft is put before the Council especially those rights referred to in the second asterisk above.
- 7.1.3.6 In this regard the following was noted:
  - That the proposal does not deal with or intend to address the issue of whether the Fundamental Rights should be confined to the Transitional Period only; it does not prejudice the question of the possible phases of the process;
  - \* That the AVU reserved its right on whether all the rights mentioned in the first asterisk above can be or should be included in a Bill of Fundamental Rights;
  - That the Ciskei reserved its rights on accepting 5.1 or 5.2 of the report in principle and during the Transition Period only;
    - That the KP stated that the point of departure of

the Technical Committee is a wrong one, i.e. that of a unitary state, with a unitary states model of Human Rights and that, rather, each State/Province/Region should be in a position to draft and accept their own Bill of Rights if they so wish, therefore, the KP rejects the decision as noted.

# JOINT STATEMENT BY THE SOUTH AFRICAN GOVERNMENT AND THE PAN AFRICANIST CONGRESS OF AZANIA

Delegations of the two parties met today as agreed to by the Negotiating Council at a special meeting on 27 May 1993. The PAC was represented by Mr Benny Alexander, Mr Gora Ebrahim, Mr Willy Seriti and Mrs Patricia de Lille. The South African Government was represented by Minister Roelf Meyer, Minister Dawie de Villiers, Mr Fanie van der Merwe and Maj-Genl Krappie Engelbrecht.

The following was agreed upon:

- 1. The PAC undertakes to discuss its commitment to armed action and its position on violence at its NEC meeting on 29 May 1993 and undertakes to give a clear unambigious report on its positions in this regard at a bilateral meeting to take place on Tuesday 1 June 1993.
- 2. The Government undertakes:
  - that Mr Thomas Likotsi, Mr Waters Thoboti and Dr Solly Skosana will be released immediately;
  - that Mr Jackie Seroke will be charged with the possession of an unlicensed fire-arm and brought to court today; and
  - that a further report on the other detainees including the following NEC members, will be submitted at the bilateral meeting on 1 June 1993:

Mr Enoch Zulu Mr Maxwell Nemadzivhanani Mr Abel Dube.

- 3. The South African Police will return material and equipment seized, not required for further investigation or prosecution, as from today.
- Other outstanding issues will be on the agenda for the bilateral meeting on 1 June 1993.

# **RESOLUTION BY THE PLANNING COMMITTEE TO THE NEGOTIATING COUNCIL MEETING OF 28 MAY 1993** ON THE COMMISSION ON REGIONS/STATES/PROVINCES

WHEREAS there appears to be broad agreement that the most suitable form of government for the future will be one which involves an allocation of powers to national and regional governments, while the differences that exist relate essentially to the boundaries, powers and functions of the regions/states/provinces and the process whereby such differences may be resolved;

**REALISING** that regional boundaries will be relevant to the electoral process, as well as to the structures of the Constitution;

ACCEPTING that the powers and functions of regions/states/provinces are crucial to issues such as the form of state and self-determination, and will be a fundamental part of the constitution/s;

**CONVINCED** that while the demarcation of boundaries is a task which appropriately should be performed by a broadly based body of suitably qualified people, who will hear representations from the public at large and from different areas of the country, issues regarding the functions and powers of regions/states/provinces can at this stage of the negotiations best be dealt with by a smaller technical committee;

**DETERMINED** to ensure that we achieve a peaceful and negotiated agreement on the democratic transformation of our country within the time frames we have set for ourselves; and

HAVING charged a technical committee with formulating as a matter of priority, recommendations on the structures, powers and functions of regions/states/provinces, on constitutional principles and on the constitution making process;

  - 1.2 Administrative considerations including the availability or non-availability of infrastructures and nodal points for services;
  - 1.3 The need or otherwise to rationalise existing structures (including the TBVC States, self-governing territories and regional governments);
  - 1.4 The necessity of limiting financial and other costs as much as is reasonably possible;
  - 1.5 The need to minimise inconvenience to the people;
  - 1.6 The need to minimise the dislocation of services;
  - 1.7 Demographic considerations;
  - 1.8 Economic viability;
  - 1.9 Development potential;
  - 1.10 Cultural and language realities;

- Allow interested parties and persons to submit their views and recommendations within a specified period, which should not be less than one month after an invitation in this regard has been published, and take these into account;
- 3. Be free to take cognisance of any other material it might wish to collect; and

4. Take cognisance of any progress made in the Negotiating Council by way of agreements on constitutional matters.
