### 1. OPENING

The meeting was opened by Dr T King at 14h05 and the agenda was adopted.

### 2. MINUTES OF THE PREVIOUS MEETING(S)

2.1 The minutes of the meeting held on 18 April 1995 were adopted subject to an amendment to para 7 which is quoted in full as follows:

'A dispute arose at the end of the meeting as some members started to leave believing that all business had been dealt with. The Chairperson subsequently closed the meeting to which Dr T King objected. Mr P Gordhan took exception to Dr King's reference to his leaving the meeting. The matter was discussed and Mr Gordhan requested an apology. This matter is unresolved.' 2.2 The minutes of the meeting Committee held on 20 April 1995 were adopted subject to the following amendment to para 5:

Mr Cronje agreed to communicate the decision to the ANC.

### 3. MATTERS ARISING

### 3.1 Technical Advisors - Remuneration

The meeting expressed their concern regarding the articles which appeared in various newspapers referring to the high remuneration paid to the Technical Advisors and to Prof Basson in particular. Prof DC Du Toit advised the meeting that following the discussion in the Core Group meeting he felt it his duty to audit Prof Basson's account and is satisfied that the fees are in order when one takes into account the volume of work undertaken by Prof Basson.

### 3.2 Workshops

3.2.1 The meeting agreed to changing the dates of two scheduled workshops as follows:

i.	15 May 1995	Local Government
ii.	22 May 1995	Inter-governmental Relations

3.2.2 The Administration was asked to liaise with Prof Davis, the Canadian High Commissioner, Mr R Humphries, Mr D van Wyk and the Centre for Policy Studies with a view to inviting two persons to address a workshop on Inter-governmental Relations. These persons should reflect the differing points of view for and against institutionalisation of mechanisms.

## 4. SUMMARY: AREAS OF AGREEMENT & CONTENTION

The meeting agreed that the document 'Summary: Areas of Agreement & Contention' prepared by the Technical Advisors on Heading 2 Phase 1, be circulated to the members of the Theme Committee for discussion at the meeting on Monday 8 May 1995.

### 5. WORK PROGRAMME

The members agreed that the draft Work Programme would be discussed at the next Core Group meeting to be held at 14h00 on Thursday 11 May 1995.

## 6. PHASE 2

The administration was asked to circulate the document 'Framework on Inter-Governmental Relations', as prepared by Prof BC Majola, for discussion at the meeting of the Theme Committee on Monday 8 May 1995. The Core Group will discuss the document at the next meeting on 11 May 1995.

### 7.1.1 Transvaal Municipal Association

The meeting discussed the request by the Transvaal Municipal Association for a hearing. The Administration was asked to:

- Acknowledge the letter and advise TMA that the matter will be followed up;
- ii. Advise the TMA of the dates for the report on Local Government;
- Fax the TMA asking them as to how much time they would need to make their verbal submission with a view to including them in public hearings which would involve national structures; and
