## SUBMISSION OF THE CONSERVATIVE PARTY TO THE TECHNICAL COMMITTEE ON FUNDAMENTAL RIGHTS

---

1. We refer the Technical Committee to the previous submission of the Conservative Party on fundamental rights.
2. We reiterate our view that each state should, if it so wishes, have the right to propose it's own bill of fundamental rights. In this regard the Conservative Party refers the Committee to it's constitutional proposals already submitted to the Technical Committee on Constitutional Affairs;
3. The Conservative Party rejects an interim constitution and therefore, rejects also so-called interim fundamental rights. Rights whether they are fundamental or otherwise, could per definition never be interim.
4. There is of course no legal guarantee that the fundamental rights which have been omitted in a so-called interim constitution, would be "re-instated" in the so-called final constitution.
