 TRADE CENTRE, KEMPTON PARK : 23 AUGUST 1993

With reference to your letter in the above connection, I hereby wish to grant permission for the proposed placard demonstration, subject to the following conditions:

1. No intimidation may take place.
2. Entrances to the relevant premises may not be occupied or obstructed.
3. A maximum of 500 (five hundred) demonstrators will be allowed.
4. The demonstration may only take place on the verge of Jones Road on the eastern side of the World Trade Centre.
5. The demonstrators are only to be transported by motor vehicle to and from the Garden Centre and Jones Road (World Trade Centre).
6. The Council will not take responsibility for any claims proceeding from the approval thus granted.
7. The demonstration may take place between the hours 07:00 to 13:00 at which the gathering will disperse.
