1. OPENING

1.1 Ms P de Lille opened the meeting at 18h15 and the agenda was adopted.

2. MINUTES

The minutes of the meeting held on Monday 3 April 1995 were adopted.

3. MATTERS ARISING

3.1 PENGUIN FILMS

A concern was expressed that the Media Department has not kept the members informed of the recording details relating to Theme Committee 3 and the parties have no basic documentation to work with. The Secretariat was asked to make the information available.

4. WORK PROGRAMME

- 4.1 The members discussed the draft Work Programme as submitted by the Core Group.
- 4.2 Mr Conje, who sits on a committee which works on the rules of Parliament, advised they have received instructions that during the whole of the next quarter Mondays and Fridays will be available for the work of the Constitutional Assembly. The only problem being the 28 April which follows a public holiday, which may result in possible low attendance on the Friday. Further time may be negotiated should the need arise.
- 4.3 The members mandated the Core Group to discuss the following Work Programme:
 - i. 6 April Political Parties submissions to the Secretariat;
 - 7 April Secretariat faxes these submissions to the Technical Advisors, members of the Core Group and those Theme Committee members whose fax numbers are known to the Secretariat;
 - 12 April Technical Advisors forward first draft report on Heading 2 Phase 1 to the Secretariat who will fax the report to members of the Core Group;
 - iv. 18 April Core group will meet to discuss the report.
 - v. 19 April Tabling of the draft report at the meeting of the Theme Committee for discussion. Any amendments will be processed by the Technical Advisors prior to the next meeting of the Theme Committee;
 - vi. 20 April Theme Committee to meet with the Technical

Advisors to discuss the draft report; and

- vii. 21 April Arrange a workshop.
- 4.4 The members discussed the redrafting of the report on Block 1 and at the request of the Technical Advisors agreed not to make a firm decision at the moment but refer the matter to the Core Group for further discussion.
- 4.5 A request was made that consideration be given to a workshop on the distribution of powers in relation to the ANC and IFP proposals.
- 4.6 The meeting agreed to adopt the work programme subject to minor adjustments.

5. GENERAL

5.1 Revised Framework

- 5.1.1 The meeting discussed the proposed framework for Heading 2
 Phase 2 and were of the view the document would be very
 useful as an agenda but as a framework the lack of
 'problemtising' of the occurrences of intergovernmental
 relations, it is not detailed enough for the writing of a
 submission.
- 5.1.2 The roles and intergovernmental relationships of the Senate, Commission on Provincial Government and Financial and Fiscal Commission, possible additional mechanisms for settling issues of dispute at various levels and whether these should be provided for in the Constitution or parliamentary legislation or be voluntary of by natural development, will be discussed.
- 5.1.3 Prof Majola advised that item '3.4 Senate' is not intended to open the debate on the Senate as a whole but to give an example of the mechanisms that can be used.
- 5.1.4 The Technical Advisors apologised for the late presentation of the document and agreed to the request by the meeting to prepare a document for distribution and discussion.
- 5.1.5 Prof Du Toit advised that there is a great deal of literature available on this subject, eg The Department of Constitutional Affairs prepared a document during the last year, which could be made available to the members of the Theme Committee before discussion takes place.
- 5.1.6 The meeting noted that as Theme Committee 2 is also dealing

with the Senate it may be useful to approach them for information.

5.2 Discussion on Constitutional Principles

The meeting continued the discussion of the meeting held on 27 March 1995 on points of clarity regarding Prof F Venter's paper "Constitutional Principles relevant to the Relationship between the National, Provincial and Local Levels of Government."

Note: A transcript of this discussion will be circulated as a separate document as soon as possible.

The members attention was drawn to the following revised documents:
