Chairperson

Area in this vicinity is in the hall now. May I say at the outset welcome to all of you present. It is very kind of you to come to this meeting. The purpose of this meeting is just to, with the benefit of the management meeting that we have just had, to just run through this document that we have circulated to you and to have an outline discussion, about the content of that document and to ensure that as we get our works programme properly launched, from today and the days that follow, that we will all know exactly what is expected of us, and that we will be able to work in tandem with one another. May I right at the outset also take this opportunity of wishing the chairpersons of the various Theme Committees well. I think it speaks for itself that it is a tremendous responsibility on the shoulders of each and every one of you and we are very appreciative of the fact that you are accepting this responsibility and I am sure that the work programme goes well. We ... it is not a state secret that we have severe time constraints, time limits, and deadlines that we will have to meet as we go

along, and I thank you so much for making yourselves available and serving in this capacity that you have taken on. May I just say that I, we have apologies for Mr Ken Andrew and Professor Dirk du Toit. That is the only apologies that I know of. Are there any other apologies? Mr Chairman, I tender apology for Mr Mtshali. I don't think he has received a notification of this meeting. He was up and down I don't think that he has got it.

Chairperson Okay, thank you so much for offering that apology, but I am sure his colleagues will deal with the substance of the resolutions of the discussions with him. Ladies and gentlemen we all have, sorry ...

a speedy recovery. Thank you very much. Ladies and gentlemen, I take it that you all do have the, what is labelled "The Briefing Document", for the joint meeting of chairpersons of Theme Committees. You are all in possession of that document. I do not intend to go through that document paragraph by paragraph and sentence by sentence, but if I may just broadly speak to that document and then put the document, but in particular also the Work Programme to you and with assistance of the Executive Director, Mr Asan Ebrahim and his staff, we will try to entertain your questions. I may just say that for those of you that are quick to conclude that the chairperson Mr Ramaphosa is on holiday, it is not true. It is simply because he worked quite hard in a previous meeting and decided to down tools, and said that it was not fair that he should chair the whole morning, and that is the reason why he is going to be an active participant sitting next to me and I am chairing this meeting by arrangement then. Ladies and gentlemen I am sure that the work, that we have gone over in the previous weeks and months are set out in this document, but just to refresh the memory, and your

memory is that the Constitutional Committee has, in broad terms, endorsed this framework. However, it needs to be emphasised once again that we regard it as flexible and we would evaluate it as we go, as we go along. It is clear that there is comprehensive work that has to be done. What we try to do is to let you have the benefit of the overall picture of what is happening, and I believe if I may just make one point, it is of, of paramount importance that, albeit Theme Committees are involved and in their particular mandates and their particular briefs, there is a bigger picture evolving. That bigger picture will evolve as the reports come to the Management Committee that will process it, and place it before the Constitutional Committee, the Constitutional Committee in turn will place it before the Constitutional Assembly. That is the Management Committee's responsibility really to ensure that the Theme Committee's, the Constitutional Committee and the Constitutional Assembly works according to the work programme. Now the major task of ensuring that the deadlines are adhered to, is also the task of the Management Committee, but the Core Groups and the chairpersons in the Theme

Committees that almost speaks for itself, has a tremendous responsibility to ensure that within the ambit of those Theme Committees you do not lose sight of the time frames as set out in the broader work programme. And I can just imagine that we will, as the heat builds up in those Theme Committees, we will have a great responsibility to ensure that it works well. Now you will all be assisted, and may I say, ably assisted by the Secretariat, but it is not their function to in any way engage in the political process as such. They will be there to ensure that administratively speaking, everything runs according to the work programme. But having said that, I cannot help but to emphasise the point that different political parties also has a tremendous responsibility to place before the Theme Committees, before the Constitutional Committee, their particular submissions. Now the chairperson has said on more than one occasion that this is a very important year, that this is the year of the Constitution and we can only meet those obligations and those objectives if we are dealing with proper submissions. I will ask Mr Ebrahim to just share some, to share some of the submissions, not in

terms of substance but in terms of what has been placed before us already. However, there is a tremendous responsibility on political parties to place before the Theme Committees and live up to the expectations as far as their submissions are concerned. The Chairman, because he would like to think and he is right, comes from a greater democratic approach than I come and is in a way is very, very democratic when he makes these kind of statements. because I come from a more authoritative background and I am not so tolerant as he is, so I think that is why I am in the chair today. By saying to me that you are, if we do not receive the submissions timeously, we are simply placed at a disadvantage. We simply, in terms of the new concepts and the new retory*, please help us and let us have your submissions timeously. Thank you so much. That is all I have to say at this moment. I will, I can now call on Mr Ebrahim to continue the discussion and explain the work programme to you and then we could have a broader discussion.

Mr Ebrahim

Thank you Chairperson. The first point I would like to make is that I just want to reiterate the role of the chairpersons

and the Core Groups, but particularly the chairpersons in making sure that we reach our objectives. There have been a call in from various of the, several of the Theme Committees during the course of last year relating to the relationship between the Management Committee and Constitutional Committee, which takes the various decisions and the Theme Committees and some of the other Theme Committees have been feeling a little left out, and there may be a need for a much more, perhaps there may be room for a forum of this sorts so as to ensure that this relationship is strengthened. May I say that with regard to the work programme, we have prepared a draft document which is placed on pages 8 and 9 of the pink document, depending on which document people are looking at. The pink document, it is pages 8 and 9. The, that is the table ...

Chairperson

If you do not have a pink document, people have different colours of documents, but the pink one is the work programme.

Mr Ebrahim

The work programme, the table that has been provided.

Now in terms of the decision of the Constitutional

Committee, this work programme barring Block 1, remains flexible, and that it is work, it is only the issues in Block 1 affecting each of the Theme Committees that have been agreed to by the Constitutional Committee. The other items relating to the following blocks are matters which still need to be clarified. So the first point that needs to be made is that the work programme is no more than a guide, a point of reference, and as a means to assist the various Theme Committees. It is only with regard to Block 1 where there has been agreement by the Constitutional Committee which is the basis on which Theme Committees will be following matters. In that respect in terms of the CA resolution it is the role and the task of the Management Committee to make sure that the work is co-ordinated as between the various Theme Committees. Now an issue which came up in the Management Committee and which needs to be raised here as well, is that many members of Theme Committees have been asking the question what happens with regard to the overlaps. Matters which affect more than one Theme Committee. This is one of the matters which are also going to have to be resolved by the Management

Committee being responsible for the process so as to ensure that matters develop in an organised way and that we don't have unnecessary duplication and two structures deciding on the same issues in different ways. So the task of the Management Committee will be to try and find a way in which there is some level of coherence between the issues being discussed between the various Theme Committees. Then the question of the Core Groups, as stated by the chairperson, is incredibly important. And if I may deal just with a bit of the question of the submissions. To give members an idea, the administration put out an advert for submissions on the first block, that is after the Constitutional Committee had agreed upon, this advert came in the second week of December and between the second, the middle of December and round about the 10th of January, which is essentially public holidays, we received submissions which is really contained in this file and is still coming in big and fast. Now in general we are quite overwhelmed and excited with the fact that we have received so many submissions to give people a broad overview as at about the 10th or the 11th and I have lost

count because they keep coming in, there have been more than 60 submissions, closing in on 70 submissions. The submissions are made up of, political parties unfortunately were the least number of submissions from political parties. Civil society and organised structures about a third of the submissions that we have received, and an equal number to that from civil society, formations have called in to our offices to say that the timing is just off, they need a little bit more time to make their submissions and this has been agreed to, as we are not going to bar people from making submissions. But the important point is that the large majority of the submissions that we have received, are from ordinary individuals. Fairly competent, fairly organised and reflecting a great amount of enthusiasm amongst the citizens in this process itself, and I have no doubt that people are going to be swamped with a large number of submissions. Now tying that into the question of the Core Groups, the Core Groups and particularly under the leadership of the chairpersons, are going to have to have the responsibility of ensuring that these submissions amongst other aspects of the functions of the Core Groups,

are attended to properly and effectively. It is going to be a large amount of work and hopefully the Core Group will be able to carry out the work under the leadership of the chairpersons. Now aside from that responsibility, our Core Groups will have to make sure that Theme Committee agendas are prepared timeously and in an organised fashion, and looking at the broad framework with regard to the programme itself. Secondly is that this is being the substantive period in writing the Constitution, it is one of the fundamental aspects of process, is going to be the development of our reports. The reports from the Theme Committees, through the Management Committees, to the Constitutional Committee and again the Core Group is going to have that responsibility of making sure that reports are filed timeously, even if it is not the final report, a draft report at least briefing the Constitutional Committee as to how far the developments with regard to particular areas of discussion, have gone, and that will facilitate matters with regard to co-ordination and process. Then invariably as we are finding in the case with Theme Committees, sets our suspicion in the administration having regard to the type of

discussions in the Theme Committees, is that various other Theme Committees want to look at issues perhaps in, in smaller groups and so on and there will be different activities undertaken by a Theme Committee. Again, it is the responsibility of the Core Group to make sure that the various activities undertaken within the Theme Committee are co-ordinated and organised in a proper way and given the necessary leadership. Then with regard to the Theme Committees they are going to be engaged in all sorts of meetings, from public participation to workshops, to seminars, to meetings in forums of this sort and so on. We can't have all 30 members of a Theme Committee attending those meetings. It is going to be the responsibility of the Core Group to organise proper delegations so as to make sure that the Theme Committee is represented in one of the meetings. Now generally in the work programme you will note that we have slotted most of the weekends as public participation activities. Invariably not all members can attend all public participation activities. Simply because members have other commitments aside from Constituency Commitments, standing committees and all sorts of other,

including their personal commitments, and so it is going to be organising proper delegations to attend the various activities for the public participation programme. lastly it is to ensure that the Theme Committee tasks and decisions are dealt with effectively and that the deadlines that we set for ourselves are realistic and are meaningful. Now having said that the work programme whilst it may be a flexible work programme, and one that requires input from Theme Committees, I should add a word of caution in that the work programme cannot be left until the last moment. It would be important for Theme Committees to consider the work programme as early as is possible. because your public participation activities, conferences, seminars and so on, are based on the actual content of your discussions. Now unless there is some clarity and some certainty with regard to the work programme, it makes a little bit of nonsense of trying to organise your public participation programmes, because you can't really organise a public hearing or any other activity even if it is a conference in a period of two weeks, or three weeks. You require a little bit more time to ensure that those events are

efficient and effective, hence it is necessary that there is some level of certainty with regard to the development of our work programmes. The question of the chairpersons, has been dealt with and I don't intend to deal with that any further. I would like to just deal with some aspects of the secretariat. I would like to give all chairpersons an assurance that we have organised our secretarial services, and the secretariat that will be providing assistance to the various committees and an assurance that we have organised our secretariat in a pretty effective way and we have no doubt that they will be able to facilitate your work effectively and efficiently. I need to say that whilst there is generally the same compliment of staff, that will be carried forward and carried through from our last cession. Theme Committee 2 has some changes effected to it. In Theme Committee 2, and I will ask the relevant members of staff to stand up so they are clearly identified, they have as managing secretary James Nene, and we have Paula Smith as the secretary for that Theme Committee. Thank you. For Theme Committee 6 which has organised various Sub-Committees, I want to give you people also an

assurance that the proper and adequate secretarial facilities have been provided and, so as to secure the efficient organisation of your work. Again just with tying in the aspect of the Core Groups and the chairpersons and its relationship to the secretarial staff, an effective Core Group and chairing leadership of a Theme Committee will ensure that the secretarial support is as efficient and effective as possible, and is organised in a proper way. To assist matters, a matter that has come up over the last few weeks, at least over the last few months during last year, were that various Theme Committees found a need at various points in time to meet with other Theme Committees and other Core Groups. These type of joint meetings will be much more effective than they have been in the past, if it is centrally organised and co-ordinated through the administration, particularly during this period of time when people are expected to cater for a large number of meetings and are effectively going to be over worked. So if Theme Committees or Core Groups wish to organise with other Theme Committees or Core Groups, sufficient enough notice should be given to the administration so as

to ensure that we co-ordinate and organise these as effectively as possible. Then with regard to the, related to the assistance and support given to Theme Committees, the question with regard to Technical Committees. The matter with regard to Technical Committees have as yet not been resolved, so when Theme Committees start now, they do not effectively have any technical assistance, although we anticipate that in the next week or two that may not be the most important aspect of a Theme Committee's functioning. I merely wish to report that as agreed by the Management Committee, the Sub-Committee dealing with the Technical Committees will be meeting today, and depending on how speedily they are able to resolve that, from the administration's point of view, we will try and secure that, and ensure that each of the Theme Committees are provided with the proper technical experts and assistants that they require. Just coming back as a final word on the question of the submissions, everybody will by now have realised that there is a large number of submissions that are expected, and we cannot, and obviously we cannot expect each member of a Theme

Committee let alone a Core Group member, to actually have read each and every submission. We are looking at various processes without adding any value judgments to the determination of these submissions, to assist members in processing the submissions. We have already started and members will find when they start with the Theme Committees, in providing members with an overview of the nature of the submissions, as well as a synopsis indicating what submissions there are and what is contained in the various submissions, so that members are easily able to identify the relevant submissions that are to be provided, that are being distributed. Can I just say at this point in time from the administration's point of view, in that we are only going to provide a synopsis and an overview, and where possible, if at all, executive summaries if it is feasible, but these will be no more than tools to assist members. They are not intended to have any political significance, or importance. They are merely as a guide, as an assistant to assist members of the Theme Committees in terms of what is contained in the submissions. So please at no point in time do we want to be understood to be

10

providing some sort of political judgment with regard to the nature of the various submissions, we are merely trying to look at various tools which members could use to extract the relevant information from Theme Committees. In that regard we are looking, we are in the process of computerising not only our present submissions, but we are also looking to computerise the submissions made to the, at the World Trade Centre so all of that information, hopefully will in the not too distant future be available on computer which would mean that access to the information will be much more efficient, organised and much more effective and details of that will be made available as soon as we have been able to conclude the necessary agreements, we will give a detailed report on that. Chairperson, perhaps I should leave it at that, and if there are any questions or clarifications that are required ...

Thank you very much. I see that Mr Smith, and Mr Tony

Mr Smith

Thank you Chair. I wonder if I could ask three, ask Mr Ebrahim a question on this work programme, or rather the schedule. We have got, today is the deadline, for the first,

of the first block marked "1", so at the end of the day all the submissions are handed in. But then as you go on to Block, 2, 3, 4 etc, we are now in a period where Theme Committees can revise those, but in terms of the programme, Block 2 has to be in by the first. What is the process between, previously all the Theme Committees had to devise a work programme which went to the secretariat and which pulled it together and then it went through to the Constitutional Committee, prior to being accepted in its format. That is a similar process that we are now to agree to the next stage, or will each Theme Committees simply unilaterally decide on how it wants its programme to be structured. Thank you.

Mr Ebrahim

Chairperson, as I understand it, it is really not the role of the director or the secretariat to determine a Theme Committee's programme. A Theme Committee will decide on its own programme, but in conjunction with the Management Committee so as to ensure that whatever various Theme Committees decide upon is organised and co-ordinated in a proper way, and otherwise we would have Theme Committees all discussing the same issues and

deciding, arriving at different decisions on the same matter. But the role of the Management Committee will be coordinate it. The appeal that I have made is that whilst
Theme Committees are requested to make an input in
terms of their work programme and how they see it
unfolding, they would have to as soon as is possible and
feasible, submit those reports and those programmes, to
the Management Committee for their consideration so that
they are able to co-ordinate the various programmes in an
effective way.

Mr Leon?

Mr Leon

Chairperson, there are two questions which arise on what has been said so far, which I would like some clarification on. The first is this, I am impressed, we all are with the response of the public to the advertising campaign and so forth, but the question is this. We can ask people to make submissions on matters in general, and we can ask people to make submissions in particular, along the lines of the work schedule which is already being published in the newspapers, but actually those submissions will be of very little value, if that is where it ends. Now what I want to ask

is this, the real way you have interaction with the public is when the actual Theme Committee or Constitutional Assembly has actually taken a view point itself, it is then necessary for that view point to then be presented to the public before it is finalised and to get the feed back on the agreed position within a particular Theme Committee. At the moment we are already engaged in one half of the process, and that is to get people's views upfront, on a particular issue such as the right to life, or freedom or information, or whatever, they will make submissions. The Committee then sits down and the Theme Committee then considers it and comes up with a draft proposal, is it then intended to take that draft proposal back to the public and get their inputs on it, before we finalise it, because if we don't go through that stage, then the public participation really becomes a theoretical exercise rather than one which really empowers people. The second issue, and I don't know if you wish to deal with it now, or tomorrow, it involves the Theme Committee which I am involved in, which is the one dealing with the Bill of Rights. The way the work programme has been organised, Mr Chairperson, is

basically as to take the issues and to divide them up over several weeks, but the issues are very different. In other words you can resolve, I would say on the Bill of Rights half of these could be settled at one meeting, because they are not going to be contested, and the seriously contested matters are going to require a far greater time to be considered. Is that going to be accommodated and the other thing that strikes me about the work programme, a third thing that I would like to raise, is that we have taken a whole category of events, of facts in relation to the Bill of Rights, Fundamental Rights, which are all agreed that these sort of matters need to go into a Bill of Rights, but according to the schedules as I understand, we have left very little space over for matters which might be put into the Bill of Rights which aren't currently in the draft Bill of Rights. Now how are we going to accommodate that within the rather rigid time frames that are binding?

I will ask Mr Ebrahim to respond but, I think the gist of what we are saying is that within the ambit of the greater programme you are very much in charge of the substance and the programme yourselves in that Theme Committee

so that, that I mean you are the captains of that Theme Committee. But we are only determining the greater outline and the greater framework of it, so how you re-organise the issues, before you as from Blocks 2, further down, is something that you will have to debate within your Theme Committee, but I would love to ask Mr Ebrahim also to respond please.

Mr Ebrahim

Chairperson, thank you, you have put it more eloquently than I could. The first question however, is a very important question and unfortunately is really a political question, more than an administrative one. But I will attempt to answer it as best as possible in terms of the resolutions which we have. With regard to the question of public participation this is taken at different levels. The submissions that are, that are being received and that are to be processed by Theme Committee is the first level of public participation and involvement. The second level of public participation and involvement is the actual physical public participation and involvement in various public hearings and so on. The third level of public participation and involvement will be when a draft is prepared and

10

published for public comment and consideration, that would be the third level of public participation and comment. And the fourth level would be the normal public participation activities, whether the various meetings or statements made by members of the public, when the matter is finally being discussed during the phase of the final argument and adoption of the Constitution. So there are at least about five different areas and aspects in respect of which the public will be participating in this activity and the public will be part of this entire process as it where. With regard to the second point, the Chairperson's response I think is the proper one, in that you are really the captains of this process and that the work programme that has been provided has been provided merely as a draft discussion document, as an aid, as a guide, it is for Theme Committees to argue that they can deal with 15 of the 20 issues in the first two meetings, because they are non contentious and the remaining five issues for the rest of the meetings, and certainly the role of the administration and I would imagine that the Management Committee would consider that very favourably, but it is really for the Theme

Committee to decide how it wishes to change that process. The only point that I made that if you do wish to change it, then change it as soon as is possible, so that there is some level of certainty with organising member's time, otherwise we tend to falter in administratively facilitating the type of programme which you wish to have. The third matter which you raise, is outside matters. Certainly there may be other outside matters which are not incorporated in the work programme, and I have no doubt that as discussion goes ahead, in various Theme Committees people will introduce new elements and new aspects which they wish to have discussed in the Theme Committee, certainly this must be introduced and raised, and I would imagine that the Management Committee should take a keen interest in these developments as well with regard to the broader framework as to how the various Theme Committees would be working, and relating to each other and with regard to the broad time frames as well. Thank you chairperson.

Chairperson

Thank you so much. Mr Ramaphosa, before I give you an opportunity, I would like to organise this debate in terms of the broader themes we are dealing with, so I don't know

whether Ms Kgositsile would like to come in on this, or hold for a minute and Mr Mahlangu whether you, with the points that you have in mind, which is relevant to the present discussion.

The concern has been saying that in regard to public participation, members of the Theme Committees will have to play an active role in attending seminars* and workshops and public hearings, throughout the country where ever possible and that we are responsible for forming a suitable delegation to do that. Now my question is, are we then saying that the Theme Committees themselves will then come out to the venues of such workshops, and that they, or that the secretariat will co-ordinate them and we will get that from the secretariat. That is impossible, to arrange one for this weekend as I can see to our problem.

Mr Ramaphosa

Thank you very much. Mr Ramaphosa is now going to .. I am not responding to the question, I actually just wanted to pull out the important question which Mr Leon has raised. I think it is, Mr Ebrahim has responded to it but I think there is another phase that we haven't highlighted and I am rather greatful that Mr Leon has raised it, even on a Monday morning, there is a flush of brilliance from him once again. The facts of the matter is we are inviting the public to participate even before we have anything in writing, just like what we have been putting across on the TBVC, that is nothing, on this screen, it is your opportunity to make an input and thereafter the Theme Committees will deal with whatever is submitted both from individuals, civil society structures and political parties. Mr Ebrahim's response in terms of publishing drafts relates in the end to the draft that we will publish after August, that is the full draft. We haven't taken into account the publications of the reports of the Theme Committees. Everything we do is going to be done in public and when the Theme Committees report and report within the framework that we have already agreed to, where there is no contention, that issues are general

agreed and suggested approaches, that may well be an area, or the type of report that we may want to make public in one way or another, through the various mechanisms that we have already agreed to, the bulletin, the Constitutional talk or whatever way, to enable the public to do precisely what Mr Leon is saying, to comment on whatever report has now been issued, even before the draft finally comes forward from the Constitutional Assembly around August or so. So that could well give the public another bind at making comment so that if an issues is being handled in a way where there is massive public protest and unhappiness, the public should be given the opportunity of ventilating their views and frustrations and unhappiness, even before we get to the draft. In my view that could actually even legitimise the work that we are doing a lot more, because it enables the public to interact in a much more effective way, rather than just to be provided with a draft Constitution, in August or later, which people may not even be able to comprehend fully, and yet if we give them binds at whatever smaller issues that we are dealing with on an ongoing basis, they are able to

respond much more effectively before a final draft is prepared. And I would like to propose that this should be taken forward and have more proposals made say by Monday, To the Constitutional Committee because it is an important aspect and we have to thank Mr Leon for his submission.

Chairperson

Thank you, Mr Ramaphosa, Mr Leon. I am sure we will process it and discuss the matter further as a proposal at management committee level. We have not given a response to Mr Mahlangu, thank you.

Mr Ebrahim

Chairperson, this is probably the most important point that I have been trying to make, which is that unless we know from a Theme Committee what its work programme is like, and what are the issues, we will not be able to organise these public hearings, do the necessary administrative and secretarial basic issues, such as inviting the relevant role players, organising the venues, organising the basic logistics and simple things like transport, advertising, public media, the relationship with the various communities and role players. So the dates, there will be very little flexibility I believe in reality with regard to the dates. We only really

have the weekends and you know it is one of very few weekends that we really have to organise these activities, but the venues and all of those considerations will be effected by the administration, obviously with comment and input where necessary, from Theme Committees, but that is really the responsibility of our Community Liaison Desk which will attend to those facilities and organisation of that programme.

May I just make a suggestion, maybe that the Theme Committees consider that aspect in their deliberations, but as soon as possible we have an in depth discussion at management levels about exactly how we intend to go about it. Ms Kgositsile?

Now I myself could not attend the meeting of the 2nd of December and recalls Sub-Theme Groups themselves are not represented in the CC-meetings and this has created a dilemma now as to

how do they go forward because the responses that they were expecting and the programme that they expect themselves in terms of hearings, was based on what they had prioritised as opposed to what was adopted by the meeting of the Constitutional Committee, and perhaps we need to assist in terms of how to go forward, because they were asking whether now they should deal with the matters that have been since put on Block 1, or do things as they had planned. So it's a very important issue that and maybe also the call group needs to also assists us by then maybe by concentrating on the process on how we embark on public participation and that process must be a wide variety of activities and also bearing in mind the kind of activities that are going to reach the majority of our people. I am sure as political formations here put together we've got a wide variety of ways that we have used at various times to try and get across. The other thing I think maybe the call group needs to help us with as a process issue is how then will we process those submissions because it's ... it's judging from for instance my experience in the Educations Select Committee the amount of submissions that we got. We got faced with the problem of actually how does one process that. I think is

it an issue that we need to look into. I'm raising that in particular so that they don't play lip service to wider consultation. We call for public participation, we call for submission just to satisfy the people that they have consulted and then entirely we do not have a process of seriously analysing and considering that and those things get presented here so that we are able to so that our own discussion are enrich. So in short comrade Chair what I'm saying is the call group needs to go back and come with a much more clearer and worked out proposal which then we can we can debate here. Thank you.

Thank you very much Doctor Nzimande. Perhaps the question of submission ... the processing of submissions is still the next item. The call group have has a decision to make but regarding the question of participation there are a little bit ... perhaps different views as to how meant by public participation. What the administration has is indicated to the chairpersons meeting is that we must just indicate what our needs are then they will make the logistics and make arrangements. Then we must come up what ... by public participation. What is it that you want? In what format do we have in mind as a Theme ?Committee? Now they need only those guiding principles then they will make all the necessary arrangements. They are there as supporting staff. We must just

Do we have rallies to be attended by certain delegations from the Theme Committee? Do we have workshops? What format do we got? We only have a view groups in a closed building where your doing it? In other words the Liaison Committee expects us to come with principles. That's what is expected that we must come. Now going about this meeting is impossible. Those principles must be there and we must look at not only at block one, there all the ten blocks so they can make

I believe the public is going to become very, very much aware of what we are going to do within the next within the next few months. Is it going to be the whole Theme Committee of just groups of people listening to them and to put questions to the people. In other words the way that one normally does with a Commission of Enquiry or with a Select Committee or with a Standing Committee if you want to have evidence. I think if you go out and attend rallies and so forth. It all will be very nice to go to that but how far will we get? How far will we get in order to get the submissions of the of the people and this is what we want. You want them on paper and you want people to give verbal evidence to us and to

It's something that we all have to agree here that how far are we prepared to say maybe on block one for how many peoples forum are we prepared for. Is it be organized in the Northern Transvaal in the rural area, it's to empower those people to understand that this constitution is meant for them.
