3. Welcome and Attendance

Matters Arising

An elected, media representative body

The Committee agreed that the Media Liaison Officer should be a two way channel to communicate between the media representatives and Communications Committee, instead of convening a media representative body at the World Trade Centre.

7.1 Attendance

It was agreed that the Co-Chairpersons should write a circular letter to party leaders as regards to how the attendance at Communications Committee Meetings could be improved.

7.2 Three extra telephones
