The meeting was chaired by Mr KM Andrew. The agenda was adopted.

2. MINUTES OF THE PREVIOUS MEETING

- **2.1** The meeting adopted the minutes subject to the following amendments:
 - 1. Correction to page 2, line 6 of the heading to read 24 October;
 - ii. Amendment to para 6.2 "... languages other than English ..." to replace "Afrikaans".

3. MATTERS ARISING

None: included in agenda items.

4. CORE GROUP REPORT

- **4.1** The chairperson gave a report of the meeting on 28 October 1994 of the Core Group. (Refer CG3/1). The Committee endorsed the decisions and recommendations of the Core Group, subject only to the matters referred to below.
- 4.2 The presence of the press and public in Core Group meetings was discussed. The meeting was referred to an earlier resolution of the Constitutional Assembly stating that all meetings of its structures are open to the press and public. This principle therefore extends to Core Group meetings subject to the discretion of the Core Group.
- **4.3** Mrs P de Lille will chair the Theme Committee meeting on 7 November 1994.
- 4.4 The Committee endorsed the appointment of an alternate for each member of the Core Group, provided that an alternate shall be a full member of Theme Committee 3

- **4.5.1** It was agreed that the Secretariat distribute copies of all external and Political Party submissions to members of the Theme Committee as they come in subject only to a Core Group discretion where a particularly long submission is received. The situation will be reviewed in the new year.
- **4.5.2** Authors of submissions must be requested to provide a 2 3 page executive summary.
- **4.5.3** The Secretariat will distribute an index of all submissions received to date.
- 4.6.1 Political parties will make submissions by 7 November 1994 in respect of both the proposed work programme and names of technical experts.
- **4.6.2** The Core Group will distribute to members of the Theme Committee a written report on all Political Party submissions on or before 11 November for discussion on 14 November 1994.

5. OTHER URGENT BUSINESS

The issue of non-South Africans participating as members of technical committees was raised. The meeting was referred to a decision of the Constitutional Committee where it was decided that participants on the Technical Committees must be South African citizens. However, non-South African citizens could be called upon to make specialised inputs.
