

Due to several factors, the Planning Committee has decided to request the Negotiating Council to cancel the meetings of the Negotiating Council on Thursday 23 September, Friday 24 September and Monday 27 September, 1993.

The reasons for this request are the following :


- * With regard to Thursday 23 September, the present session of Parliament makes it impossible for a number of delegates to attend the Negotiating Council meeting;
- * With regard to Friday 24 September, it is the opinion of the Planning Committee that given the limited scope of the Thirteenth Report of the Technical Committee on Constitutional Issues, as well as the urgent progress needed in bi-laterals, it is not worth the time and money to call the Negotiating Council for one day;
- * With regard to Monday 27 September, the S A Government and Inkatha Freedom Party have an important bi-lateral meeting starting on Sunday 26 September and lasting through the whole of Monday. As this is crucial to progress in the Multi-Party Negotiating Process it is felt that Monday's session should also be cancelled.
