#### 3. CORE GROUP REPORT ON WORK PLAN

- 3.1 The Chairperson gave a report on the Core Group meeting of Thursday 27 October 1994 where submissions received were processed.
  - A three-phased approach recommended by NP was adopted
    - the core group agreed that ANC, DP and Freedom Front's submissions be integrated. It was further agreed that the work plan and reports thereof be started from 30 October 1994 and finalised by 15 November 1994
  - it was agreed that parties that have not submitted names or have made no submissions be given until Friday 4 November 1994 to do so and brief CVs of the names given be attached

#### 3.2 <u>Electoral Systems</u>

The Theme Committee agreed that a separate commission be appointed to deal with the issue of the electoral system.

#### 3.3 Volkstaat and Traditional Leaders

The meeting agreed that a joint commission between Theme Committees 2,5 and 6 be established to deal with the issue of Volkstaat and Traditional leaders. It was further agreed that the cochairpersons meet with the co-chairpersons of the above committees and arrange a joint commission meeting. It was recommended that traditional leaders be consulted on all levels.

#### 3.4 <u>Separation of powers</u>

It was noted that separation of powers is in relation to Executive legislature and judiciary. The meeting agreed that Theme Committee 2 will take note of Provincial Government and Local Authorities because they are essentially Theme Committee 3's task. It was also agreed that the core group organise/arrange a meeting with Theme Committee 3 to look at overlapping areas.

#### 3.5 Separate reports to be submitted

It was agreed that separate reports on issues requiring such reports be submitted on a continual basis.

- 3.6 It was agreed that the "type of experts required" [item J of the Theme Committee Work Plan Report] be deleted.
- 3.7 It was agreed that an advertisement be placed for the general public to make submissions with regard to Theme Committee 2's constitutional issues [CA Resolutions]

- 4.2 It was agreed that pending approval by the Theme Committee the priority work plan item would be "separation of powers and the executive". A sub-committee would be established to undertake this task as soon as possible.
