RE: SUBMISSIONS TO THE COMMISSION ON NATIONAL SYMBOLS

1. Background

During September 1993 the Negotiating Council of the Multi-Party Negotiating Process passed a resolution appointing a Commission on National Symbols.

2. Terms of Reference

The Commission was mandated to:

- * make recommendations on a national flag, a coat of arms, a seal and a national anthem for the constitution for the transition period;
- * invite proposals from all interested persons or parties and to allow at least one month for submissions to be made;
- * take into account the diversity of the South African population but concentrate on the unifying function that national symbols must serve, and
- * in its recommendations submit at least four alternative flags and coats of arms.

3. Time Frames

As the Commission was requested to make recommendations to the Negotiating Council before the end of October 1993, submissions in the three categories mentioned below should be made as soon as possible, but not later than 12h00 on Wednesday 13 October 1993 to the following address:

4. **Introductory Remarks**

The process of eliciting submissions for a national flag, coat of arms and anthem should be inclusive in order to ensure that they are truly representative. All the people of South Africa, groups and individuals, in both urban and rural areas, are invited to participate. Proposals are invited from all interested persons and parties and local leaders should assist in initiating the process. Participants should be drawn from all walks of life including the following kinds of groupings: schools, religious, cultural, civic, local, youth, women, students, stokvels, specialist societies e.g. musical, heraldic and vexillological.

4.1 **National Flag**

- The flag should be of a unique design.
- It should promote national unity.
- It should be so simple that even a child can recognisably draw it.
- Primary colours are preferred.
- Designs should be submitted in full colour, preferably A4 size.
- A brief motivation for the design may also be included.

4.2. **Coat of Arms**

- The design of the coat of arms should be unique and representative of the country and its people.
- Designs should be submitted in full colour, preferably A4 size.
- A motto should also be suggested.
- A brief motivation for the design may be included.

4.3. **National anthem**

- The anthem should express and promote national unity.
- The composition should be original and submissions should be accompanied by lyrics in any of the languages of South Africa, by sheet music and a demonstration tape.
- It may be submitted in tonic solfa or staff notation.

5. Submissions may include the name and address of the person or organisation if they so wish.
6. It should be noted that this request for public participation is not a competition. All designs and the proposals for an anthem will however receive careful consideration.
7. The Commission on National Symbols reserves the right to use such elements from the proposals as it deems fit in its submissions to the Negotiating Council.

Appendix D

DEMOCRACY AND VOTER EDUCATION PRIOR TO THE ESTABLISHMENT OF THE INDEPENDENT ELECTION COMMISSION**1. MOTIVATION**

- 1.1 The urgent need for a timeous democracy and voter education programme is increasingly emphasised by parliamentary and extra-parliamentary groups.
- 1.2 Arguments that it would be wise to defer this issue until the independent Election Commission (IEC) has been established, should be carefully weighed against an increasingly tight time schedule and the enormity of the task. Sufficient reason seems to exist to justify an interim multi-party election committee which could inter alia begin to address this issue.
- 1.3 The present absence of clear guidelines for democracy and voter education is unfortunately resulting in a proliferation of campaigns with varying degrees of accuracy. This is not only contributing to confusion, but is likely to necessitate that future campaigns will have to rectify inaccuracies and that some of the already limited time available will have to be spent on this non-productive aspect.
- 1.4 Potentially large sources of funding for democracy and voters education have a major problem as to the allocation of such funds. In order to ensure that funds from these diverse sources are properly channelled, managed and judiciously spent, serious consideration should immediately be given to establishing a trust fund as a repository under the control of the interim multi-party election committee, pending the establishment of the IEC.

2. PROPOSED STRATEGY

- 2.1 In order to ensure that a well-planned democracy and voter education programme is timeously initiated, it is recommended that the Negotiating Council give serious consideration to the following strategy:
 - the immediate establishment of an interim multi-party election committee which could inter alia be entrusted with the task of planning a comprehensive multi-media democracy and voter education campaign and timeously booking provisional media space;
 - the immediate establishment of a trust fund managed by the interim multi-party election committee with the view to receiving international, local and Government contributions and allocating these funds;
 - the registration, by the proposed interim multi-party election committee, of existing democracy and voter education programmes, the co-ordination of such activities, the furnishing of information and the provision of materials;

- the establishment of an interim Code of Conduct, to which all organisations involved in democracy and voter education will be required to subscribe.

2.2 The proposed interim multi-party election committee is only intended to bridge the period between now and the establishment of the IEC. It will ensure that certain essential steps are taken timeously with a view to their ratification or amendment by the IEC.

3. **PROPOSED DEMOCRACY AND VOTER EDUCATION PROGRAMME**

3.1 Despite the time constraint, it is of critical importance that certain basic aspects of democracy, along with the mechanics of the voting process, be addressed. At least the following items should be considered for inclusion:

- political tolerance and voter behaviour;
- intimidation;
- secrecy of the ballot;
- responsibility to vote;
- eligibility to vote;
- voter identification;
- voting procedures;
- where and when to vote;
- the election results;
- after the election.

3.2 Inadequate as this list may be, the available time and the relevant literacy levels dictate that it would be foolish to attempt a more comprehensive curriculum. Frequent repetition of simple messages would seem to be the most preferable approach.

3.3 Although there is a fervour democracy, it is also unfortunately true that this is a complex concept which will require ongoing and intensive education. The possibility of democracy education continuing after the election, should therefore be seriously considered.

4. **CONCLUSION**

A comprehensive programme of democracy and voter education is an essential precaution to ensure that the election result will not be contested, as such education will hopefully contribute towards a high degree of voter participation and a relatively low percentage of spoilt ballot papers.

It is almost two months now that education at the Lebowa bantustand has been brought to a stand still because of a dispute between Sadtu and the Lebowa education department.

The issue that has brought this crisis is the fact that Sadtu demands repayments of monies deducted from their members salaries during the 1991 strike, on the other hand, the Lebowa Government seems unwilling to comply with the demand. This is frustrating to the parents and students and other concerned community organisations which want a solution in this matter because the victims here are students who are caught on a cross fire. It is even more serious because final examinations are around the corner.

The PAC Northern Tvl Region with the backing of parents is calling on the negotiating council to discuss and get solutions to the crisis.





Re: Education crisis in Lebowa:

At a mass meeting held in Lebowakgomo on Friday, 17-September-1993, the community of Lebowakgomo resolved that we should communicate the following to you. That:

1. Education in Lebowa ground to a halt since 02-August-1993, owing to the Government's refusal to meet the teachers demands i.e. repayment of monies deducted during the 1991 and 1992 South African Democratic Teachers Union (SADTU) strikes.
2. The 1991 and 1992 strikes were sparked off by arbitrary transfer and dismissals of teachers and recognition of SADTU.
3. Realising that the deductions effected on their salaries were illegal, SADTU took the matter to the supreme court and the court decided in favour of SADTU.
4. To date, the Lebowa government Education Department has failed to comply with the court ruling.
5. The prolonged strike impacts negatively on the education of the black children. Moreover, exams are just around the corner and we fear for the worst matric results in Lebowa.
6. The people of Lebowa do not think that their future can be shaped by the Lebowa Government because its representatives do not have their interests at heart. This can be attributed to the failure of the Lebowa Government to resolve the education crisis in a peaceful manner. Instead, the said government has responded to peaceful protests against its reluctance to comply with the court order through teargas, brutal assaults and indiscrimi-

nate arrests.

- 7. It is against this backdrop that we request the Negotiating Council to withdraw representative of the Lebowa Government, Mr. M. J. Mahlangu (who is one of the rotating chairperson) in particular, until they resolve the education crisis in Lebowa.
- 8. This matter is of national importance and we hope you will treat this matter with the urgency it deserves and we look forward to hearing from you

INTERIM CONSTITUTION : ADMINISTRATION OF JUSTICE

I refer to my letter of 10 August 1993 and my subsequent discussions with mr Zam Titus on Monday 6 September 1993.

We have since then received and considered the twelfth report of the technical committee on constitutional issues. We have after consultation with the Association of Law Societies, NADEL, the BLA, the chief justice and other members of the judiciary, decided to request you to facilitate a meeting with the technical committee on constitutional issues as envisaged in my discussions with mr Titus. Our proposal is as follows :

- 1 A meeting as soon as possible on the Witwatersrand on a Saturday or Sunday.
- 2 We suggest that the meeting be attended by the technical committee on constitutional issues and representatives of
 - the GCB
 - the Association of Law Societies
 - NADEL
 - the BLA
 - selected members of the judiciary.

The GCB, the Association of Law Societies and individual judges have already indicated their support for the proposal. We are still awaiting the response of NADEL and the BLA.

- 3 We would suggest that the meeting be in the nature of a briefing session. Its primary purpose would accordingly be for the technical committee to share with the meeting, its thinking behind the proposals put forward in its twelfth report.
- 4 We have in mind an informal, "off the record" discussion.

Would you please urgently consider our request. I would only be too happy to meet with you or any other members of the planning committee to discuss and develop our proposal. Would you please let me know at your earliest convenience when such a meeting could be arranged.

**PROPOSAL FOR THE ACCEPTANCE AND IMPLEMENTATION OF A
SCHEME TO PROMOTE A JUST AND DEMOCRATIC NATIONAL
ELECTION**

1. BACKGROUND

It is common knowledge that when South Africa's first democratic election takes place in April 1994, some 20 million people will become part of a national electoral process for the first time in their lives. These people will be totally unfamiliar with the political hype, aggressive campaigning and electoral procedures to which they will be subjected.

If the election is to be contested in a rational, fair and democratic environment, it is absolutely essential that this "new" electorate be comprehensively informed and educated.

2. CURRENT SITUATION

The above-mentioned objective can be achieved through personal presentations, distribution of printed material, the press and television and radio broadcasts. The most cost-effective and practical vehicle would undoubtedly be radio broadcasts - but only if every eligible voter in the country had access to a radio.

3. PROPOSAL

Our organisation is favourably positioned to obtain sufficient local, overseas & even government sponsorships to ensure that a low-cost radio can be donated to every single member of the "new" electorate, i.e. every person over the age of 18 years.

The appropriate electoral agency can then compile introductory literature in all relevant languages and distribute it together with each radio as a package.

4. ADVANTAGES

- Every eligible voter in the country will be in possession of his/her own radio, thereby ensuring the largest possible audience for official education and information campaigns.
- Such broadcasting campaigns can be both extensive and intensive, with the accent on continual escalation and reinforcement, in all relevant languages.
- There is no cost whatever to the voter.
- Maximum benefit can be obtained from the ample broadcasting time which the SABC will be making available to all political parties.


5. REQUIREMENTS AND MODUS OPERANDI

Our organization would need the Election Committee to agree to the following in order to make the proposed scenario a reality:

- 5.1 We require an official letter of accreditation, authorising us to canvass the necessary sponsorships. A trust fund would be established for the deposit of all sponsorships, and we would abide by any appropriate control measures designed to ensure that such monies are not misappropriated
- 5.2 At a time or times to be agreed upon, the trust fund resources will be utilised by ourselves to purchase the necessary radios, and delivery of the consignment to the election committee will be arranged.
- 5.3 Our organization's remuneration will be obtained by a marginal percentage (to be negotiated and agreed upon) levied on the total value of the consignment. Any funds not utilised for the purchase of radios will be made available to the Election Committee to utilise as they see fit.
- 5.4 We would require official confirmation that our organisation has the sole right to obtain the proposed sponsorships and further implement the entire proposal as described.

6. CONCLUSION:

In the event of any further clarification being required, we can consult on a 24 hour basis.
