RE: **REPRESENTATION ON THE COMMUNICATIONS COMMITTEE**

When the Multi-Party Negotiating Process was structured in March this year provision was made for each Official Party to nominate a person to act as a representative on the Communications Committee. This person could be in addition to your normal delegates and advisors.

Addendum A is the list of representatives currently nominated.

The Committee has become very concerned at the poor attendance of some of the representatives. Out of a potential 26 members there are now seldom more than fifteen and on one occasion only nine. As most of the members travel long distances and sacrifice time to take part in a meeting, it would be tragic for some to arrive and find that a quorum does not exist.

The Committee feels that it has a duty, not only to the Multi-Party Negotiating Process, but to the population at large in respect of the promulgation of information. As a result it needs as much support as possible.

In order to avoid the embarrassment of listing those who seldom, if ever attend, the Committee would like you to review your own party representation against Addendum A and take any necessary measures to correct the situation.

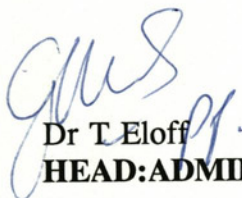
