NP PROPOSALS

Background:

1. A phase approach rather than an item classification is proposed.
2. Priorities are valid only in procedural management but certainly not in terms of omissions of "lower priority" subthemes. All themes (2.11) have to be given equal attention.
3. Overlapping of activities will be identified and should not initially be given to the Theme committees since every Theme committee will look at items with a specific focus.
