TREAMELE Whereas in every community of musen beings there may be detected some fors, however the rude, of regulating authority, which determines in some degree, however slight, the relations of the members of the community with one another and whereas the forme and functions of this authority are as diverse as the times and places in which these communities are found ; and whereas we, members of the community of South Africa convinced that far us to contest, test, mould and reject the present existing social ideas, beliefs, epinions, aims, laws and objectives should meet and legally form a Pelitical party.

We therefore proclaim surgelves a pelitical party.

THE NAME OF THE PARTY WILL BE HLANGANART PEOPLES PARTY The Party will have three levels namely "The Branches; The Regions ; The Mational The Branches will be fermed by 200 members in an area. A Region will be formed by three or more branches. The National will be formed by 2 members elected from every Region. At the head of the National there will be a President elected by a full house of the National Body. The house will further elect his deputy; Secretary; Minute Secretary; Treasury; four executive committee members. all efficials of the Farty will be elected by Sallet (secrets veting) CONDUCTED by a neutral many who will have been nominated and agreed upon by the whole house concer--ned. The whole election process will follow democratic standards. The President will see to it that the prestige and the integrity of the Party is kept intact. The running of the Party will not be a one-man's show but the active concern of all the administrative body and members of the Party as such. The President will use his preregative where need be. At ne time will anybedy enter or commit the Party inte any contract with any perman, association etc. without the concern of the President and the Administrative Bedy, The Deputy will act in the absence of the President. Secretaries at different levels will see to it that the records of the Party are up-te-date, The treasury will keep an hencat record of the finances of the Party. A Financial Year will be decided upon by the National and only audited financial statements will be accepted. and with the branches it will be at the Mass Maeting when new effice-bearers are elacted. Regions and Branches elections will be yearly; National every three years. In tipes of crisis the President will have the right to freeze the finances of the Farty and instruct the Treasury to give a Financial Statement before the Beard Of Inquiry elected by The National er at & Mess Meeting. Nebedy ence arrested, presecuted and found guilty for original effences except for his pelitical beliefs shall be eligible for election to any effice in the Party. IT Branch Level the precedure for the election of the office-bearers will be the same : Chair-personinis Deputy; The Secretary ; The Minute Secretary ; The Treasury; and four Committee Members (this will further be determined by the size of the -Branch in that area.). The Four Committee-members will serve as co-ordinators unless a provision for this effice has already been made. Membership of the Party shall be sought by paying an amount as shall have been

fieldby the Party. On payment of thisamount/fee the individual shall be issued with the membership card. Membership epen enly to adults from 18 years upward. This fee will then be sent to the Region The Region will in turn sund a certain percentage of the money received to the Branch for the maintenance of that . Branch.

Each Branch shall send as many members to the Region as shall be determined by The National. The Region shall be formed by elected members from various Branches. The Branches will have a right to device means of raising funds.

In times of crisis the Branches will appeal to the Region and if a Region fails te come up with acceptable solution to the problems the matter will then be

Decisions taken by a unanimous as jerify shall be binding. Members of The National can be elected Tres both The Regions and The Branches.

The Region shall have a Chair-person plan Benuty (The Secretary)The Himte Secretary (The Treasury and six or more members) (Secretary the Member of the Beneralist te represent the Branches equally.

The Party at all Levels will upheld and enshring basic human rights and therefore will function as a no-racial, non-sexy, democratic body always striving for the improvement of the quality of the life of all South Africans.
