PREAMBLE

Whereas in every community of human beings there may be detected some form, however crude, of regulating authority, which determines in some degree, however slight, the relations of the members of the community with one another; and whereas the forms and functions of this authority are as diverse as the times and places in which these communities are found; and whereas we, members of the community of South Africa convinced that for us to contest, test, mould and reject the present existing social ideas, beliefs, opinions, aims, laws and objectives should meet and legally form a Political party.

We therefore proclaim ourselves a political party.

THE NAME OF THE PARTY WILL BE HLANGANANI PEOPLES PARTY

The Party will have three levels namely: The Branches; The Regions; The National. The Branches will be formed by 200 members in an area.

A Region will be formed by three or more branches.

The National will be formed by 2 members elected from every Region.

At the head of the National there will be a President elected by a full house of the National Body. The house will further elect his deputy; Secretary; Minute Secretary; Treasury; four executive committee members.

All officials of the Party will be elected by Ballot (secret vote) CONDUCTED by a neutral man, who will have been nominated and agreed upon by the whole house concerned. The whole election process will follow democratic standards.

The President will see to it that the prestige and the integrity of the Party is kept intact.

The running of the Party will not be a one-man's show but the active concern of all the administrative body and members of the Party as such.

The President will use his prerogative where need be.

At no time will anybody enter or commit the Party into any contract with any person, association etc. without the concern of the President and the Administrative Body.

The Deputy will act in the absence of the President.

Secretaries at different levels will see to it that the records of the Party are up-to-date.

The treasury will keep an honest record of the finances of the Party.

A Financial Year will be decided upon by the National and only audited financial statements will be accepted.

And with the branches it will be at the Mass Meeting when new office-bearers are elected. Regions and Branches elections will be yearly; National every three years.

In times of crisis the President will have the right to freeze the finances of the Party and instruct the Treasury to give a Financial Statement before the Board Of Inquiry elected by The National or at a Mass Meeting.

Nobody once arrested, prosecuted and found guilty for criminal offences except for his political beliefs shall be eligible for election to any office in the Party.

At Branch Level the procedure for the election of the office-bearers will be the same:

Chair-person; his Deputy; The Secretary; The Minute Secretary; The Treasury; and four Committee Members (this will further be determined by the size of the Branch in that area).

The Four Committee-members will serve as co-ordinators unless a provision for this office has already been made.

Membership of the Party shall be sought by paying an amount as shall have been fixed by the Party. On payment of this amount/fee the individual shall be issued with the membership card. Membership open only to adults from 18 years upward. This fee will then be sent to the Region. The Region will in turn send a certain percentage of the money received to the Branch for the maintenance of that Branch.

Each Branch shall send as many members to the Region as shall be determined by The National. The Region shall be formed by elected members from various Branches. The Branches will have a right to devise means of raising funds.

In times of crisis the Branches will appeal to the Region and if a Region fails to come up with acceptable solution to the problems the matter will then be

referred to The National where a final binding decision will be taken.
 The Chair-person in consultation with the other office-bearers will look after the life of the Branch.
 The members of the Party have a right to query anomalies cited in the Party by a written note clearly out-laying such complaints to the secretary through the co-ordinator or his representative in the Branch.
 Misbehaviour in the Party may cause one a suspension of not more than a year, or a complete expulsion from the Party. Under all circumstances justice will always take its full course.
 Misbehaviour/Misconduct at the meetings can cause a member suspension from the meeting.
 Decisions taken by a unanimous majority shall be binding.
 Members of The National can be elected from both The Regions and The Branches.
 The Region shall have a Chair-person ; The Deputy ; The Secretary ; The Minute Secretary ; The Treasury and six or more members depending on the number of Branches to represent the Branches equally.

Traditional Leaders

The interaction of the Party with Traditional Leaders will be based on the understanding of the Constitution of Centralaqa.

The Tradition Of the Party

The Party at all Levels will uphold and enshrine basic human rights and therefore will function as a no-racial, non-sexy, democratic body always striving for the improvement of the quality of the life of all South Africans.

Alliance

The Party will ally itself with all Parties and Organisations which are struggling to maintain South Africa as one undivided country.
