## INTRODUCTION:

Following extensive consultation within the country and with partners abroad, the South African Council of Churches (SACC) and the South African Catholic Bishops Conference (SACBC) have jointly sponsored a programme called the **Ecumenical Monitoring Programme in South Africa (EMPSA)**. The aim of EMPSA is to bring ecumenical international partners to South Africa, to monitor violence in the country, as well as the negotiations process.

## OBJECTIVES

1. to provide a mechanism of monitoring violence in South Africa, within the broad context of the political processes;
2. to monitor and report on the process of negotiations for a peaceful transition to a democratic, non-racial South Africa, according to universally accepted democratic principles;
3. to monitor and report on the electoral proceedings that are determined by the negotiating partners, so as to assist the participation of all South Africans in an electoral process.

## MONITORING SCHEME

The first phase of the scheme, which focuses on violence and the process of negotiations, will involve three kinds of monitoring teams:

### 1. EMINENT PERSONS GROUPS (EPG)

The EPG will be brought into the country for periods of up to one week. They will interact with personalities and institutions, take necessary steps and make recommendations in resolving the crisis.

### 2. GROUPS OF EXPERTS

The group of experts will be brought into the country for periods of 10-14 days or as the need arises. They will deal with technical issues such as constitutional matters, conflict resolution, policing, human rights and other areas as may be required. This will involve training local people in these skills.

### 3. OPERATIONAL MONITORS

These teams will spend 4-6 weeks at a time in the country. The monitors will operate in various parts of the country and work alongside



national monitors (church and secular) to provide for continuous presence in troubled spots. The teams will listen, observe, collect, analyse and communicate information acquired, assist in devising strategies to counter the violence and make representations where necessary.

These three types of monitoring schemes will be modified accordingly, when the election process starts.
