## Apologies

Apologies were noted from P. Coetzer.

#### 2. Welcome

The Chairperson welcomed the members of the Committee to the meeting. Apologies were read as shown above. It was noted that out of 26 participating parties 15 representatives were present.

6.1 The Committee agreed that it will form a Sub-Committee which should draw up a code of conduct to deal with media issues.

The Committee agreed to meet on the 23 June 1993 from 14h00 to discuss the code of conduct as the main item on the agenda.

#### 6.2 Media Packs

6.2.1 The Committee recommended that all documentation relating to the Multi-Party Negotiating Council Process should be made available to representatives of the media free of charge and as soon as it is available, except when embargoed.

#### 6.3 Administrative assistance with media liaison

6.3.1 The Committee recommended that a specific person should be appointed by Administration to deal with media queries and disseminate documentation.

## 6.4 Media coverage.

6.4.1 The Committee called for the establishment of a specific room, provided with adequate lighting, for media coverage.

## 6.5 Media representation

6.5.1 The Committee agreed that media representatives should be present in meetings of the Communications Committee when needed.

7. Date of Next meeting: The Committee agreed to meet again on 24 June 1993 from 14h00.

The Committee agreed that the members of the Sub-Committee should be notified of the next date of meeting by administration.
