## REI THE FUNDAMENTAL BILL OF RIGHTS

Salt Shakers is a Christian grassroots organisation comprised of thousands of concerned citizens around South Africa. We have been informed that you are finalizing the new Bill of Rights in the next few days and are very disturbed by the inclusion of "sexual orientation" in your anti-discriminatory clause.

, Do you realise that if we as a nation include "sexual orientation" in the fundamental Bill of Rights, we will be the first country in the world to constitutionally protect the homosexual lifestyle!

Sexual orientation is a broad term that can easily include not only homosexuals and lesbians but also paedophilia, bestiality and other perversions.

The implications of including "sexual prientation" in the anti-discriminatory clause are far reaching. This, in effect, would mean:

- All existing sodomy laws must be abolished, legalising homosexuality, lesbianism, paedophilia, bestiality, and any other sexual perversion.

- The legalisation of marriages between homosexual and lesbian couples and the right to adopt children.

- It would make it a federal offense for churches, schools, and businesses to refuse to hire homosexuals for any reason.

- Homosexuality would have to be taught as a legitimate alternative lifestyle to our children in schools and in textbooks.

- It would require that affirmative action must also be applied to homosexuals.

Proponents of this "sexual orientation" clause demand a favoured status as a "minority". We believe that that is an insult to those legitimately deemed to be minorities (on basis of race, colour, national origin, religious conviction, etc.. )
