
7. New issues

7.1 Administration

It was agreed that:

- 7.1.4 That the co-chairpersons be mandated to meet with representatives of the Planning Committee to establish a date for the Plenary. It was also agreed that the co-chairpersons convene this meeting and that a report should be given in the next two weeks.
- 7.1.5 It was also agreed that in any future meetings between representatives of the Communications Committee and representatives of any other committees of the Multi-Party Negotiating Process, a written report should be presented in order facilitate more structured discussions of those issues.
- 7.1.6 That in addition to notices sent by Administration, the co-chairpersons need to follow-up in order to ensure that all members are informed well in advance.
