

This Multi-Party Negotiations Planning Conference, meeting at the World Trade Centre, Johannesburg on 5 and 6 March 1993,

Conference resolves that:

1. Codesa shall be renamed
2. It will reconvene as a matter of national urgency not later than 25 March 1993;
3. each participating organisation will send two delegates and two advisers;
4. the first meeting will determine:
 - 4.1 chairpersonship
 - 4.2 how to accommodate the views of those participants who were not in Codesa in relation to the agreements reached in Codesa;
 - 4.3 how these agreements can serve as a constructive foundation for the resumed negotiations process to build on;
 - 4.4 how this forum shall be structured;
 - 4.5 the role of the international community;
5. all participants are required to make an unqualified commitment to this process as a pre-requisite for their participation;

FIRST PROPOSED COMPROMISE RESOLUTION (EGLIN)

We, the parties, organisations and administrations assembled at this Multi-planning Planning Conference:

BELIEVING that the problems of our country should be resolved peacefully through negotiation;

Resolve:

1. to commit ourselves individually and collectively to the resumption of multi-party negotiations within one month in order to move as speedily as possible towards the drafting and adoption of a new Constitution
2. to charge the facilitating committee of this conference with the responsibility of deciding upon and implementing the steps that are necessary to give effect to the above resolution.

● A SECOND PROPOSED COMPROMISE RESOLUTION (SECRETARIAT)

We, the parties, organisations and administrations assembled in this Multi-party Planning Conference:

1. Realising:
 - 1.1 Our responsibility to resolve the problems of our country peacefully through a process of negotiation;
 - 1.2 that the recovery of the economy is dependent on this;
 - 1.3 and that our country and the world are looking at us to make progress toward a non-racial, non-sexist and democratic future;
2. Now resolve: to commit ourselves to **urgent** multi-party negotiations within the next month, in order to move as speedily as possible to the drafting and adoption of a new constitution.

**FOURTH PROPOSED AMENDMENT (AVU)
