DRAFT MINUTES OF THE MEETING OF THE PLANNING COMMITTEE HELD ON MONDAY 24 MAY 1993 AT 11H40 AT THE WORLD TRADE CENTRE

1. Moment of Prayer/Meditation

A moment of prayer/meditation was observed by all members.

2. Welcome and Attendance

All members were welcomed.

3. Ratification of Agenda

The agenda was ratified with the following amendments:

- 3.1 The addition of an Item 5.8 to read "Election Date";
- 3.2 The addition of an Item 6.3 to read "New Participants Progress Report";
- 3.3 The addition of an Item 7.2 to read "Report with regard to the Couriers".



4. Minutes

4.1 Minutes of the meeting of 14 May 1993:

- 4.1.1 The minutes were adopted with the following amendments:
 - Item 4.1.2, the word "resubmitting" to read "resubmission";
 - Item 5.1.3.1, the second sentence, the word "informed" to read "informal";
 - * Item 5.1.4.1, the word "general" to read "print".
- 4.1.2 Matters Arising:
 - 4.1.2.1 It was noted that the Proposed Resolution from the Planning Committee to the Negotiating Council on Violence had been submitted to the Technical Committee on Violence.
 - 4.1.2.2 The issue of whether the Technical Committee on Violence had considered how the Goldstone Commission can liaise with the Multi-Party Negotiating Process was raised. Administration will report back in this regard.

4.2 Minutes of the meeting of 17 May 1993:

- 4.2.1 The minutes were adopted with no amendments.
- 4.2.2 No matters arising were noted.

4.3 Minutes of the meeting of 18 May 1993:

- 4.3.1 The minutes were adopted with the following amendment:
 - * Item 3, first sentence, the word "three" to read "four".
- 4.3.2 No matters arising were noted.

5. Substantive Issues

- 5.1 Receipt of Second Reports from the Technical Committees:
 - 5.1.1 General Issues:



- 5.1.1.1 The Sub-Committee provided the Planning Committee with an overview with regard to the Technical Committees and their reports.
- 5.1.1.2 It was agreed that the Planning Committee should assist the Negotiating Council in dealing with the reports and submit recommendations with regard to each report.
- 5.1.1.3 It was agreed that each report should be taken as read in the meeting of the Negotiating Council. Furthermore, each report should be dealt with separately and in its entirety.
- 5.1.1.4 It was suggested that co-ordination is needed between the drafting processes. It was further suggested that the Sub-Committee be mandated to interact with the Technical Committees in this regard.

5.1.2 Technical Committee on Violence:

- 5.1.2.1 After discussion it was agreed to put forward the following recommendations of the Technical Committee to the meeting of the Negotiating Council on Tuesday 25 May 1993:
 - All parties at the Multi-Party Negotiating Process must sign the National Peace Accord;
 - * Participants should be requested to make submissions with regard to the proposed Peace Corps;
- 5.1.2.2 It was further agreed to recommend that the Negotiating Council instructs the Technical Committee to prepare a preliminary report and recommendations on the issues as identified for the next meeting of the Negotiating Council on Friday 28 May 1993. This would ensure that the third report from the Technical Committee was of a substantive nature.
- 5.1.2.3 The Sub-Committee was mandated to offer guidance to the Technical Committee.

5.1.3 Technical Committee on Constitutional Issues:

5.1.3.1 After discussion it was agreed that the report did not fully comply with the instructions given to the

Technical Committee at the last meeting of the Negotiating Council on 18 May 1993. Furthermore, the report was not in a form to take decisions.

- 5.1.3.2 It was therefore agreed to recommend to the Negotiating Council that, as a result of the need to have more pointed discussion in the Negotiating Council, the Technical Committee be encouraged to submit drafts on:
 - Various constitutional principles; including
 - * The constitutional principle/s on states/regions/provinces.

Where differences existed, the Technical Committee would prepare drafts on each option and may even propose a draft compromise position.

- 5.1.3.3 The Sub-Committee was requested to liaise with the Technical Committee with a view to submitting certain drafts to the Negotiating Council meeting on Tuesday 25 May 1993. Where this was not possible the drafts should be completed by Thursday 27 May 1993 at 14h00 for the meeting of the Negotiating Council on Friday 28 May 1993.
- 5.1.3.4 It was agreed that the Planning Committee would meet on Tuesday 28 May 1993 to receive a report from the Sub-Committee in this regard.
- 5.1.3.5 FT Mdlalose noted that the was not happy with the fast pace at which the process was working.

5.1.4 Technical Committee on Fundamental Human Rights During the Transition:

- 5.1.4.1 After discussion it was agreed that there is a need to clarify the definition of "Fundamental Human Rights during the Transition". It was suggested that the Chairperson of the Negotiating Council guide discussion in the meeting with a view to achieving this clarity.
- 5.1.4.2 It was agreed to put forward the following recommendations of the Technical Committee to the meeting of the Negotiating Council:



- Item 5.1 of the Technical Committee Report refers : That comments are invited from the Negotiating Council on the various rights and freedoms in the first and second categories with a view to give the Technical Committee some feedback on their proposals;
- Item 5.2 of the Technical Committee Report refers : That the Negotiating Council accepts the principle of justiciability and that discussion be invited with regard to the relevant institution;
- Item 5.3 of the Technical Committee Report refers : That the Technical Committee be instructed to submit formulations;
- * Item 5.4 of the Technical Committee Report refers : That discussion on the third category be continued.

5.1.5 Technical Committee on the Independent Election Commission:

*

- 5.1.5.1 After discussion it was agreed that the report be tabled and that the Planning Committee recommend that the Negotiating Council agree in principle with the report.
- 5.1.5.2 Furthermore, that all participants be requested to submit inputs with possible amendments and/or additions to the draft legislation by Thursday 27 May 1993 at 14h00. These will be forwarded to the Technical Committee.
- 5.1.5.3 It was noted that the Technical Committee should present a further report to the meeting of the Negotiating Council on Tuesday 1 June 1993.

5.1.6 Technical Committee on the Independent Media Commission:

- 5.1.6.1 After discussion it was agreed that, as a result of the fact that the sixth and relevant draft of the proposed legislation would only be circulated at the meeting of the Negotiating Council on Tuesday 25 May 1993, the Planning Committee recommends that the Negotiating Council notes the report, subject to its wishes.
- 5.1.6.2 It was further agreed that all participants be requested to submit inputs with possible amendments and/or additions to the draft legislation by Thursday 27 May



1993 at 14h00. These will be forwarded to the Technical Committee, who will table an amended report on Friday 28 May 1993.

5.1.6.3 It was agreed that this issue be dealt with at the meeting of the Negotiating Council on Friday 28 May 1993 as a matter of priority.

5.1.7 Technical Committee on the Amendment or Repeal of Legislation impeding Free Political Activity and Discriminatory Legislation:

It was noted that a report will only be received for the meeting of the Negotiating Council on 1 June 1993 as per the instructions of the Negotiating Council at its last meeting.

5.1.8 Technical Committee on the TEC and its Sub-Councils:

After discussion it was agreed to recommend:

- * That the Technical Committee should continue drafting;
- * Where there are different views on a particular issue, the Technical Committee should submit drafts on each view;
- * This drafting should be completed by Wednesday at 14h00 for consideration at the meeting of the Negotiating Council on Friday 28 May 1993.

5.2 Commission on Regions:

- 5.2.1 The Sub-Committee presented a proposal to the Planning Committee for their consideration. Various names were suggested.
- 5.2.2 After discussion and the expression of various views, it was agreed that the Sub-Committee consider this issue further and submit a further recommendation to the meeting of the Planning Committee on Tuesday 25 May 1993 at 09h00. Furthermore, the Sub-Committee was mandated to consider names outside those nominated, if so required to take into account the concerns and views expressed.
- 5.2.3 A recommendation from the Sub-Committee on the Chairpersonship of the Commission should also be included. It was agreed to informally canvas the issue of Chairpersonship.
- 5.2.4 The proposed Terms of Reference for the Commission were distributed and would be considered at the meeting of the Planning Committee on Tuesday 25 May 1993 at 09h00.



5.3 Election Date:

It was agreed that this item should remain on the agenda of the Planning Committee and the Negotiating Council.

6. **Procedural Issues**

- 6.1 Structuring of the discussion of Reports from Technical Committees in the meeting of the Negotiating Council:
 - 6.1.1 The reports should be taken as read.
 - 6.1.2 It was agreed that no discussion should be entered into with the Technical Committees. Only questions of clarity or information should be addressed to the Technical Committee, and the spokesperson for each Technical Committee would respond, after having highlighted various issues in the report.
 - 6.1.3 It was agreed to confirm this approach at the meeting of the Planning Committee on Tuesday 25 May 1993 at 09h00.

6.2 Media Arrangements:

A report was presented by the Administration and the following was noted:

- 6.2.1 The SABC would cover the proceedings of the meeting of the Negotiating Council of 25 May 1993 as no permanent contractor had yet been engaged.
- 6.2.2 A memorandum would be distributed to all members of the media laying out the arrangements with regard to the payment of Multi-Party Negotiating Process document. Furthermore, the documentation received by the media for the last meeting of the Negotiating Council (18 May 1993) would be paid for by the media.

6.3 New Participants:

- 6.3.1 A progress report was presented by the Administration and the following was noted:
 - 6.3.1.1 Only one response had been received so far.
 - 6.3.1.2 The newspaper survey was complete.
 - 6.3.1.3 Furthermore, the Administration would process the responses and the survey, forward the information to

the Sub-Committee for further processing and making recommendations on to the Planning Committee.

- 6.3.1.4 It was agreed that the Administration formulate a report with regard to the above for the meeting of the Negotiating Council of Tuesday 25 May 1993.

 - 6.3.2.1 That the Orange Free State Traditional Leaders had resolved the internal problems they were experiencing;
 - 6.3.2.2 That the Cape Traditional Leaders were still holding a series of meetings to resolve their internal problems;
 - 6.3.2.3 That the Transvaal Traditional Leaders had discussed informally with various participants a compromise solution to their internal problems. It would be suggested informally to these Traditional Leaders that they submit their proposal formally to the Negotiating Council.
 - 6.3.2.4 With regard to the issue of the Natal Traditional Leaders, a progress report could possibly be made to the next meeting of the Planning Committee on Tuesday 1 June 1993.

STATEMENT TO THE PARTICIPANTS IN THE MULTI-PARTY NEGOTIATING PROCESS FROM THE BUSINESS FORUM

The Business Forum, being widely representative of the business community in South Africa, considers that the transformation process in South Africa is at a critical stage. Although recent reports are positive, the negotiation process appears to remain vulnerable and fragile. This has been exacerbated by persistent violence and the education crisis. Unless the resumed political negotiations succeed, the impact on employment and the economy - which is in its fifth year of recession - will be devastating. It is clear that the economy and the country cannot afford another setback of the kind that occurred with the breakdown of Codesa II.

The business sector is the engine of the country's economic performance. It is the principal employer of labour, the major contributor to the national wealth, and the prime generator of new jobs. It cannot fulfil these functions in a climate of uncertainty, instability, disorder and violence - to which the basic answer must be a realistic and rapid political settlement. South Africa desperately needs a political solution acceptable to most South Africans and the international community, and which will stand the test of time.

The Business Forum stresses that another political impasse will lead to more business closures, the withdrawal and withholding of investment, a further flight of capital and skilled manpower and further loss of job opportunities. Business confidence, already at a very low level, will suffer another blow. A successful transitional agreement on the other hand, will provide the climate for the economy to grow and for South Africa to address comprehensively the problem of poverty.

The Business Forum has a vision of a prosperous non-racial democratic South Africa and remains committed and anxious to help in attaining that goal. But every political party has a heavy burden of responsibility to create conditions - especially regarding the promotion of peace - in which that vision can be attained. Business believes that the political leadership of our country is equal to the task, provided that a statesmanlike approach is adopted towards the gravity of the situation.

The Business Forum therefore appeals to all the participants in the current negotiations to make every effort to ensure a successful outcome to these discussions. Business hopes that all political players will show the necessary flexibility, ability to compromise and realism to keep the negotiations on track - and to ensure that the process underway reaches early conclusions which are as inclusive as possible.

OPEN LETTER TO THE PROPLE OF SOUTH AFRICAN AND ITS POLITICAL LEADERS

South Africans must stop killing each other. It is unthinkable that a country whose political leaders are locked into sophisticated and serious negotiations to bring peace and stability to this country, can tolerate the violence sweeping the country and threatening to destroy us all.

We must all thank God for the National Peace Accord. Without it, who knows where we would be. The National Peace Accord succeeds in spite of the political leadership and thanks to the work of the thousands of dedicated South Africans and international observers who labour day and night, often in life-threatening circumstances, to prevent the pot of violence from boiling over.

In signing the Peace Accord our leaders promised to stem the rising tide of the dehumanising violence and to ease the burden of the millions of South Africans living in fear. That was in September 1991. Since then more South Africans live in fear than ever before.

The political violence is overshadowed by the rising crime rate that forces South Africans to live in fortresses - be it on the farms, in the suburbs or townships or informal settlements. The solution is political and therefore, the snails pace at which we are moving, is close to becoming a war crime in itself.

The National Peace Accord provides protection for all South Africans including politicians. A Peace Accord debased by contemptuous disregard, polarises society, increases insecurity and exposes people to the despicable acts which we now see daily on our television screens.

We demand an urgent meeting of the signatories to re-Enough! commit themselves to the National Peace Accord and this time, regional and local leadership must sign.

Non-signatories who may have problems with the wording, must sign a peace pledge to give legitimacy to their participation in negotiations.

Security forces must be held to the Code of Conduct and private armies must be made transparent and held equally accountable. Their need for existence, must be examined with sensitivity, but, above all, with great urgency. The commanders of security forces must be responsible to the National Peace Accord structures for their adherence to their codes of conduct.
