PRESENT JURISDICTION OF THE OMBUDSMAN

1. To investigate dishonesty regarding public moneys:

All institutions dealing with public moneys. This also includes subsidized institutions like universities and technicons.

2. To investigate maladministration:

All organs of the central State.

3. To investigate enrichment, receipt of an advantage, and improper prejudice (the latter including the classical Ombudsman functions):

- 3.1 All organs of the central State.

- 3.2 All local authorities, including Town and City Councils, Municipalities, Town Committees, Regional Services Councils, Joint Services Councils, Health Committees, Divisional Councils.

- 3.3 All organs of provincial authorities.

- 3.4 Institutions, funds, companies or corporations or other organizations which were established by law and whose accounts are in pursuance of that law audited by the Auditor-General. These
