1. OPENING

3. MATTERS ARISING

3.1 FINANCIAL AND FISCAL WORKSHOP

It was suggested that as KM Andrew was attending the workshop representing TC6.2 and members of the Freedom Front are unavailable, the ANC should send two persons. The matter were referred to Prof Du Toit and the Secretariat to settle.

4. WORK PROGRAMME

- 4.1 The meeting agreed that as the Work Schedule had not yet been adopted by the Constitutional Assembly, the draft schedule as prepared by the Core Group last week would be circulated to the Theme Committee for their perusal.
- 4.2 The members were of the view that the 3½ days (18 from 12h00 24 April) set aside for CA work must be fully utilised. Issues to be addressed would include the Political Party submissions Block 2, Phase 1, the draft Report on Phase 1 and the Work Programme. The Core Group would finalise the programme the following week.
- 4.2.1 The meeting agreed that the Political Party submissions for Block 2 Phase 1 due on 7 April be forwarded immediately to the Technical Advisors who would prepare the first draft Report by 12 April 1995 for distribution and discussion by the Core Group on 18 April 1995.
- 4.2.2 The Secretariat was asked to fax the Political Party submissions to those members who have access to fax machines and ensure that copies were in the members pigeonholes by 18 April 1995.
- 4.2.3 The meeting further agreed that any amendments would be made to the report for submission to the Theme Committee meeting on 19 April 1995.
- 4.2.4 The Technical Advisors might be asked to attend one meeting to answer queries.
- 4.3.1 The members expressed concern that information requested from the Technical Advisors was outstanding. The meeting asked the Secretariat to write to the Convenor of the Technical Advisors for the following documents to be submitted to the Core Group, and report back accordingly:
 - i. By Wednesday 5 April 1995 revised report on Block 1 for party approval; and
 - ii. By Monday 3 April 1995 proposed framework for Block 2, Phase 2.
- 4.3.2 The meeting asked the Secretariat to write to the Executive Director formally requesting that the Theme Committee be given the chance to view the Constitutional Text prior to submission to the Constitutional Committee.

1. OPENING

The meeting was opened by P de Lille and the agenda was approved.

2. MINUTES OF THE PREVIOUS MEETING

The minutes of the meeting held on 30 March 1995 were adopted to show that KM Andrew opened the meeting (para 1).

3. MATTERS ARISING

None

4. WORK PROGRAMME

4.1 The Technical Advisors will meet in the Transvaal early next week to put together a report on Heading 1 Phase 2 to be cast as far as possible in the format as agreed upon by the Constitutional Committee outlining the contentious and non-contentious issues. Prof Venter was of the view that it was not very easy to identify contentious and non-contentious issues before there had been a debate.

- 4.2.1 Prof Venter advised that there was a real difficulty in rewriting the report on Block 1. The submissions on which that report was based were very wide ranging often in vague and general terms.
- 4.2.2 The meeting agreed that the Technical Advisors would:
 - a) Write a report on those issues contained in the first report which were prima facie in contrary to the those issues which were Constitutional Principles, for submission to the Constitutional Committee.
 - b) Write a report recapping what workshops the Theme Committee had been involved in, what papers had been submitted and give their perspective of where we were going.
- 4.3.1 The meeting agreed on the following programme:

Tues 18 April 11h00	Core Group to discuss the report on Heading 2 Phase 1, amend where necessary and distribute to the members of the Theme Committee.
Wed 19 April 14h00-18h00	Theme Committee to discuss the draft report and Technical Advisors to rewrite as necessary, Secretariat to distribute on the same day or very early on Thursday 20 April. Prof Basson and Prof Majola to attend.
Thur 20 April 14h00-18h00	Theme Committee to discuss the second draft of the report. Prof Basson and possibly Prof Davis to attend.
Fri 21 April 09h00-12h30 V454	Workshop on Local Government with input by the Technical Advisors attached to the Ad Hoc Committee on Local Government.

The Core Group would meet if necessary.

- 4.3.2 The meeting agreed that there were three purposes of the discussions around the report:
 - i. To understand party positions;

- ii. To be able to define where the contentious areas were; and
- iii. To explore whether there was a way forward in terms of those contentious issues. This was very important so that the Constitutional Committee did not have to rehash the debate which had taken place in the Theme Committee.
- 4.3.3 Prof Venter would not be able to attend Theme Committee meetings until the end of June due to prior teaching commitments. Prof Majola would not be able to attend meetings on 20 - 21 April. Professors Basson and Davis would available for the week of 18 - 21 April.
- 4.4 The meeting agreed that the Technical Advisors would present a paper on *Intergovernmental Relations* on Monday 24 April 1995.

Mr Andrew's letter of resignation as Co-chairperson of the Theme Committee was tabled for discussion at the next meeting of the Core Group.
