#### PART II

#### 1. NATURE OF THE RIGHT (Application of Constitutional Principle II)

#### 1.1 Non-contentious Issues

1.1.1 Right is not a universally accepted fundamental right. (The NP and ACDP stated their support for the inclusion of this clause).

#### 1.2 Contentious\ Outstanding<sup>2</sup> Issues

- 1.2.1 The right is "enjoined to the value of human dignity and underscores the morality of the work ethic." ACDP
- 1.2.2 Section 26 as it now stands in the Interim Constitution should be retained.

#### 2. CONTENT AND SCOPE OF THE RIGHT

#### 2.1 Contentious\ Outstanding Issues

- 2.1.1 Clause as it stands it is "either too vague to be meaningful, or it is so broad that it will impact on every aspect of human territory" - ANC
- 2.1.2 It is "doubtful as to whether any meaningful protection is afforded by the inclusion of this right" DP
- 2.1.3 The DP propose a new clause under the heading "Entitlement to the Essentials of Life":
  - (1) "Every citizen shall be entitled to the food and water necessary for survival; to shelter from the elements; to basic health care; to a basic education; and to a clean and healthy environment:
  - (2) It is the province of parliament... to deiced how these entitlements are to be realised..."

A Bill of Rights enacting such a clause, would acknowledge also that the manner in which entitlement is realised is a matter for the legislature and the executive".

<sup>2</sup> It should be noted that items marked "Outstanding" do not signify disagreement amongst political parties or contention.
Parties felt that these matters could best be dealt with at the level of the Constitutional Committee, where negotiation could take place.
