### 4.1 National Flag

- The flag should be of a unique design.
- It should promote national unity.
- It should be so simple that even a child can recognisably draw it.
- Primary colours are preferred.
- Designs should be submitted in full colour, preferably A4 size.
- A brief motivation for the design may also be included.

## 4.2. Coat of Arms

- The design of the coat of arms should be unique and representative of the country and its people.
- Designs should be submitted in full colour, preferably A4 size.
- A motto should also be suggested.
- A brief motivation for the design may be included.

#### 4.3. National anthem

- The anthem should express and promote national unity.
- The composition should be original and submissions should be accompanied by lyrics in any of the languages of South Africa, by sheet music and a demonstration tape.
- It may be submitted in tonic solfa or staff notation.
- 5. Submissions may include the name and address of the person or organisation if they so wish.
- 6. It should be noted that this request for public participation is not a competition. All designs and the proposals for an anthem will however receive careful consideration.
- 7. The Commission on National Symbols reserves the right to use such elements from the proposals as it deems fit in its submissions to the Negotiating Council.

# MORANDUM OF THE LEBOWA PUBLIC SERVANTS TO THE MULTI PARTY NEGOTIATING COUNCIL

We, the Public Servants of Lebowa Government Service gathered on this the 4th October 1993 at the Lebowakgomo Civic Centre and:

### (a) REALISING

- 1. The crisis emanating from the Unilateral take-over of the Lebowa Homeland by the Pretoria Regime.
- 2. That the Pretoria Regime is bent on entrenching itself despite its corrupt History.
- 3. That the Pretoria Regime is in this situation posing as a Messiah although proved otherwise.
- 4. That all Bantustans are not only fraudulent but inherently corrupt.
- 5. That the corrupt Pretoria Regime has selectively targeted the Lebowa Bantustan amongst all corrupt Bantustans.

### (b) CONSEQUENTLY

- 1. Nullifying the promotions of the Civil Servants in Lebowa.
- 2. Delaying the timeous remuneration of Civil Servants.
- 3. Being unable to pay Pensioners their due grants.
- 4. Disrupting Essential Services in the area particularly Health Services.
- 5. Besieging the Lebowakgomo Township, the Lebowa Administration offices and the abduction of Computer personnel through the Security Forces.

### (c)THEREFORE RESOLVE

- 1. That the Unilateral take-over of the Lebowa Homeland Administration be immediately suspended pending the installation of a legitimate body such as the T.E.C.
- 2. To reiterate our call for the Pretoria Regime and all Bantustans to resign.
- 3. That all Bantustan Administrations and the Regime's surrogates should be taken over by a legitimate body, which will institute an independent commission of inquiry to investigate all corrupt practices.
- 4. That the Nullification of promotions of Civil Servants in Lebowa be reversed pending a report by an independent commission of inquiry.
- 5. That old age Pensions and Disability grants be paid out immediately.
- 6. That the Abduction of the Computer Personnel be condemned in the strongest possible terms and that Abductors be criminally charged and prosecuted.

That all Essential Services be restored with immediate effect.

8. That the Security Forces be withdrawn immediately.

9. That all Agreements between Lebowa Government, Public Servants and SADTU be honoured and implemented with immediate effect.

In conclusion, We Lebowa Public Servants generally believe in the legitimacy of the Multi Party Negotiating process and are looking forward to the Negotiating Council to use its power and influence to cause Pretoria Regime to observe the letter and spirit of negotiations and accede to our demands, for the sake of Peace and Stability in this most Peaceful and Stable region in the whole of the REPUBLIC OF SOUTH AFRICA.
