THE INDEPENDENT MEDIA COMMISSION BILL

1. We are writing to you on behalf of our client, the National Association of Broadcasters of South and Southern Africa ("the NAB").
2. The NAB has, only today for the first time, obtained a copy of the most recent draft, namely the Eighth Draft, of the Independent Media Commission Bill.
3. The NAB believes that the proposed Bill has significant implications for the broadcasting industry that the NAB represents, and the NAB would, therefore, wish for an opportunity to comment on the proposed Bill. The NAB did, in fact, write to the Technical Committee some time ago, requesting a copy of the Bill and an opportunity to comment thereon.
4. We have been advised that the Technical Committee is required to complete its work on the Bill by the afternoon of Tuesday 27 July 1993. Accordingly, the NAB would wish to file its comments with the Committee as soon as possible, and hopes to be able to do so no later than the morning of Monday 26 July 1993. The NAB trusts that this will still enable the Committee to consider its comments.
5. In the event that the Technical Committee's deadlines change, so enabling the NAB to have more time within which to prepare and file its submission, we would be grateful if you would advise us accordingly.
