

FOUNDED 30-06-92

1. The name of the choir shall be Kwamhlanga Adult Choir
2. The slogan shall be the impossible shall be made possible.
3. Code of Conduct (All equal in the cloak of music)
 - a. No attitude towards :-
 - (i) Domestic life
 - (ii) Employment
 - (iii) Social life
 - b. All members shall be regular and punctual.
 - c. No status display, no emotions, no nepotism, no promotion of arguments, no destructive criticism or offensive remarks, no personal grudges.
 - d. More realistic and productive remarks.
 - e. Avoid a blame - frame - syndrome.
4. AIMS AND OBJECTIVES:
 - a. Kindle the love for music once more.
 - b. Pave ways for talented music lovers.
 - c. Substitute laxity, boredom, dissillusionment and frustration.
 - d. Feature in all relevent competitions.
 - e. Support and liven - up all sorts of future occassions.
 - f. Promote composition of music pieces in all types of music.
 - g. Restore lost health conditions.
 - h. Represent the community without fail.
 - i. Communicate with other regions, countries and races in musical expressions.
 - j. Promote and consolidate discipline, administration and respect among each other.
 - k. Inculcate the love for music ever.
5. MEMBERSHIP:
 - a. Membership shall ever be open to all interested persons.
 - b. Annual registration shall be R10,00 per person when joining.
 - c. Meetings shall be rehearsals, general meeting and emergencies.
 - d. Any suggestions or corrections should come via person in charge.
6. COMMITTEE:

The Executive Committee shall consist of, the Chairperson, Vice, the Secretary and Assistant, the Treasurer, three Co-ordinates (3), three Conductors (3) and three D.C. (3)

7. **RULES AND REGULATIONS:**
- a. Meetings shall be attended punctually and regularly without fail.
 - b. No cliques and conspiracy shall be allowed.
 - c. Defiance to rules and regulations shall be punishable by:-
 - (i) Suspension, expulsion or a fine decided upon by the choir in conjunction with the Executive.
 - d. Any misplacement, mishandling or theft of the assets of the choir shall be replaced by the responsible, failing which legal proceedings shall be constituted.
 - e. Apologies shall be in writing.
 - f. All members of the choir shall commit themselves to abide by the Code of Conduct plus rules and regulations.
 - g. A fine of R1,00 per 30 minutes late coming and over, a fine of R5,00 if no apology was tendered.
 - h.x No one shall be allowed to take anything that is not his belonging.
 - i. Practice days shall be Monday to Thursday 16H30.
 - j. Mondays can be suspended only if there is no pressure.
 - k. Performances to be attended shall be competitions, marriages, funerals and graduations to direct members only.

CONDOLENCE:

A contribution of R5,00 shall be collected per member only to direct members.

Term of office shall be 12 months calendar year from inception of Committee.
