1. AGENDA:

It was agreed that Clause 23, Property would be discussed.

2. AMENDMENTS TO PREVIOUS MINUTES:

2.1 Item 4.2 - the last paragraph should be as a separate issue on its own and not included under the discussions regarding Clause 2 - Equality and should have been recorded as:

"10. S. A. Law Commission:

Mr Maharaj took note of the Ad Hoc Committee's request that the S. A. Law Commission also be approached for comments on the Technical Committee's Seventh (or Ninth) Report."

2.2 Item 9.1 - the first word should be "Clause" (in the singular) and not as stated.

3. CLAUSE 23. PROPERTY

3.1 The Ad Hoc Committee agreed that the following principles should form the basis of the clause on property rights:

First Principle:

All rights to property shall be recognised and guaranteed.

Second Principle:

The State shall have the right to expropriate property in the public interest.

Third Principle:

In the case of expropriation, compensation shall be by agreement or failing agreement, shall be determined by a court of law.

Fourth Principle:

The basis for determining compensation shall be just and equitable taking into account all relevant factors.

Fifth Principle:

There shall be proper payment of compensation.

Sixth Principle:

Expropriation in the public interest may be for the purpose of restoring land to those persons who were forcibly dispossessed pursuant to apartheid policies and practices.

Notes:

1. "all relevant factors" - This phrase is shorthand for all the factors contained in the present 23(2) and raised in various submissions. The motivation for the adoption of this general phrase will be included in the report referred to below.

AD HOC/FUNDAMENTAL RIGHTS MINUTES/25 August 1993 2. "persons" - The drafting should take into account that in many instances the rights are held communally.
