ENTRENCHMENTS

Elections

- ... (1) Any election for the members of a legislature referred to in this Constitution, shall be conducted by an Independent Electoral Commission with the following objects:
 - (a) to administer, organize, supervise and conduct free and fair elections for the National Assembly and all other legislatures;
 - (b) to promote conditions conducive to free and fair elections;
 - (c) to determine and certify the results of elections; and to certify to what extent such elections have been free and fair;
 - (d) to conduct voter education; and
 - (e) to make and enforce regulations for the achievement of such objects.
 - (2) Unless new provision is made for the appointment of an Independent Electoral Commission and the regulation of elections, the provisions of the Independent Electoral Commission Act, 1993, and the Electoral Act, 1993, shall, despite the dissolution of the said Commission as contemplated in sections 9 and 35 of the Independent Electoral Commission Act, 1993, and as far as the provisions of the said Acts are not inconsistent with this Constitution, be deemed to be in full force and effect in respect of any election for any legislature to be held under this Constitution.

Entrenchment of certain laws

... The provisions of section 4 of the Broadcasting Act, 1976 (Act No. 73 of 1976), and the Independent Broadcasting Authority Act, 1993, shall not be repealed or amended unless such repeal or amendment is approved by a two-third majority of all the members of the National Assembly.

SCHEDULE 7

Constitutional Principles

I

Provision shall be made for an Independent Electoral Commission to administer, organize and conduct free and fair elections in terms of the Constitution and the Electoral Act in an impartial and non-partisan way.

II

Provision shall be made for an Independent Broadcasting Authority to be responsible for the regulation of broadcasting activities in the public interest on a permanent basis in an impartial and non-partisan way.
