MATTER: DISPUTE BETWEEN TPA(NYL) AND TSUKOTA CO-ORDINATING COMMITTEE

DEAR SIR/S

TSUKOTA CO-ORDINATING COMMITTEE, A COMMUNITY BASED ORGANISATION HEREBY ASK YOU TO ADVANCE AN INTERVENTION IN THE SERIOUS DISCORD BETWEEN THE ABOVE STATED PARTIES.

FOR THE PAST DECADE OR SO WE HAVE BEEN AT LOGGARIGROS WITH THE "TPA" OVER THEIR HERETIC INTENTIONS TO DEMOLISH OUR TOWNSHIP FOR REASONS THAT SUITS AN APARTHEID PROGRAMME.

AS OF NOW OUR TOWNSHIP IS REPELLED AND WE HAVE SECURED THE "I.D.T" SUBSIDY SCHEME FOR A 1000 SITES. "TPA" HAS DRAWN A ^{TOWNSHIP} MAP WHICH PROVIDES FOR 495 "I.D.T" SERVICES SITES AND 105 SO CALLED COMMERCIAL SITES WHICH TPA WILL SERVICE AND SELL AT A PROFIT.

WE ARE SAYING THIS IS PROVOCATIVE AND IRRESPONSIBLE BECAUSE PEOPLE WHO CAN AFFORD COMMERCIAL SITES CAN JUST AS WELL GET THEMSELVES HOUSES IN WHITE DOMINATED SUBURBS.

WE ARE WORRIED THAT OUR CONSTITUENCY IS BEING HOMOGENISSED IN FAVOUR OF THOSE WHO CAN AFFORD. OUR ARGUMENT IS THAT THE POOR PEOPLE THAT WE UNQUOTE REPRESENT SHOULD BE GIVEN SERVICES SITES BEFORE ANYONE ELSE.

WE LOOK FORWARD TO A SITUATION WHERE THE NEGOTIATION COUNCIL WILL ASSIST IN MAKING THE "TPA" TO STOP RENTSON AND BE ABLE TO SAY YES, FIRST THINGS FIRST - WHICH IMPLICITY SUGGESTS THAT THOSE (POOR) PEOPLE WHO WERE AT THE FOREFRONT OF THE STRUGGLE SHOULD BE THE FIRST TO RECEIVE ATTENTION FROM EVERY STATEHOLDER.

- THE NEGOTIATIONS^{COUNCIL} IS THEREFORE ASKED TO URGE THE "TPA" TO ENTER INTO GENUINE NEGOTIATIONS AROUND THE EXCLUSION OF THE POOR HOMELESS PEOPLE OF ISHIKOTOA.

In Display of Good Faith THE "TPA" SHOULD STOP SERVING THE "105" SO CALLED COMMERCIAL SITES UNTIL CONVINCING NEGOTIATIONS ARE ENDED INTO.
