WHEREAS you have been convicted of an offence under
Section eleven of the abovementioned Act;

NOW THEREFORE, I, BALTHAZAR JOHANNES VORSTER, in
my capacity as Minister of Justice for the Republic of South
Africa, by virtue of the powers conferred upon me by paragraph
(e) of sub-section one of section five of the Supression of
Communism Act, 1950, (Act No. 44 of 1950), as amended, do
hereby prohibit you from attending, during a period of five
years as from the date that this notice is delivered or
tendered to you, any gathering in any place within the Republic
of South Africa or the territory of South West Africa.



(hereinafter referred to as the accused)

THAT the accused is guilty of the offence of contravening Section 11(f) read with Section 5(1)(e) of Act 44 of 1950 as amended.

IN THAT upon or about the 29th day of January, 1963, and at or near Park Road, in the district of Wynberg and within the Republic of South Africa, the said accused being a person who has been prohibited from attending any gathering in any place within the Republic of South Africa during the period 2/9/1961 to 2/9/1966, did wrongfully and unlawfully attend a gathering to wit a meeting of a number of persons.

ANNEXURE

THE STATE VERSUS: REGINALD KENNETH SEPTEMBER,
(hereinafter referred to as the accused)

THAT the accused is guilty of the offence of contravening Section 11(f) read with Section 5(1)(e) of Act 44 of 1950 as amended.

IN THAT upon or about the 29th day of January, 1963, and at or near Park Road, in the district of Wynberg and in the Regional Division of the Cape Peninsula and within the Republic of South Africa, the said accused being a person who has been prohibited from attending any gathering in any place within the Republic of South Africa during the period 17/7/1961 to 17/7/1966, did wrongfully and unlawfully attend a gathering, to wit a meeting of a number of persons.
