

re: Invitation to attend conference on "South African Media in the Transition to Democracy"

The Centre for Development Studies (CDS) at the University of the Western Cape, in association with the Campaign for Open Media (COM) have pleasure in inviting you to nominate two members of the above working group to attend an important National Media Conference to be held in Cape Town from January 31st to 2nd February 1992. The conference will be held at the University of the Western Cape.

- The conference is being convened by an Eminent Media Person's Group which includes:
- * Nadine Godimer (Nobel Prize Winner for Literature)
- * Prof Njabulo Ndebelë (formerly head of the department of African Literature at the University of the Witwatersrand and currently vice rector designate of the University of the Western Cape)
- * Harvey Tyson (Former Editor-in-Chief of the Star newspaper and currently a member of the Board of the Argus Printing and Publishing Company)
- * Cyril Madlala (Managing Editor of the UmAfrika newspaper in Natal one of the fastest growing independent or "alternative" newspapers in the country
- * Jane Raphaety (Editor of Femina magazine)
- * Raymond Louw (chairperson of COM)
- * Mandia Tyala (Deputy editor of the Evening Post and Weekend Post newspapers in the Eastern Cape)
- * Clive Emdon (Former head of the Department of Journalism and Public Relations at the Natal.

 Fechnikon and currently assistant director at the Technikon)

University of Stellenbosch and a former member of the board of the SABC)

We envisage that this will be a high profile conference which will formulate resolutions to be tabled with the Convention for a Democratic South Africa (CODESA) and other appropriate forums to ensure that the media, as a democratic tool, can play its role in helping to bring about free and fair elections. The conference will also consider steps to be taken to ensure that the media is able to facilitate the widest possible debate and free flow of information and opinion during the transitional period. The conference will further consider measures to promote high standards of journalistic ethics during the transitional phase.

The aim of the conference is to arrive at concrete and practical steps to be taken so that a free and unfettered media can provide fair and accurate coverage of the transitional process in the public interest.

We are enclosing a mission statement on the conference prepared by the chairperson of COM, Mr Raymond Louw. On a point of information, COM is an umbrella body which includes three media trade unions (the South African Union of Journalists, the Association of Democratic Journalists and the Media Workers Association of South Africa) as well as the Anti-Censorship Action Group, the Film and Allied Workers Organisation, the Congress of South African Writers and a few media individuals. In this form these organisations and individuals pool their efforts to strive for a free media in South Africa.

The objective and brief of the CDS is to facilitate the process of the development of policy options for a post-apartheid South Africa through research, workshops and conferences together with the democratic forces in South Africa and elsewhere, its association with COM in this conference is thus part of this effort.

We are inviting representatives of all the main political parties and movements in South Africa. This includes the African National Congress, the Pan Africanist Congress, the Azanian People's Organisation, the National Party, the Democratic Party, the Conservative Party, the Labour Party, Solidarity, the South African Communist Party and the Transvaal and Natal Indian Congresses. Representatives of all the main media groupings (mainstream and alternative, broadcast and print, employer and union, media academics and lawyers) will also be invited. In addition representatives of civic society as well as religious groupings and the major national trade union federations will be invited.

Various foreign and international media organisations are also receiving invitations including the International Federation of Journalists, the Commonwealth Journalists Association, the International Press Institute, the International Organisation of Journalists, the Commonwealth Print Union and the Commonwealth Broadcasting Association. It is hoped that various media personalities from Namibia will also attend as well as the Swedish Press Ombudsman.

We apologise for this late invitation. South Africa's transition from apartheid to a non-racial democracy has already began and we have had to act at short notice in order to address the role of the media during this historically significant phase.

Could you please confirm BY NOT LATER THAN JANUARY 24 whether you will be able to accept this invitation. Please also indicate whether we need to arrange accommodation and/or flight bookings for you. Should flight bookings be required, also indicate the departure point. We expect delegates to arrive on the evening of 30th January.
