Making 5 educ. programmes for ^{Scandinavian} Danish TV adults - 14-16

One programme - dedic. to Trib. Popular.

One of best parts of our trip - very well looked after by Min. of Justice.

I was v. impressed by the Trib. Judge Sacramento suggested all levels - TR's. But in a 20 min. programme - better to concentrate on fewer.

Namialo & Lumbo - Locality.

Nampula - Provincial.

In Denmark we saw film courts, was astonishing to me that I could even film there. We wanted to film - ^{even} sexual violence - unfortunately - didn't turn up, had to be called for at his house. So we filmed a thing without licence case. penalty was more severe than in Denmark - 10 days jail & fine. Because many similar cases. More or less like in Denmark.

Woman prosecutor, 1 w. amongst the judges.

In Lumbo - Namido - I had never had experience like that.

Lumbo - they re-enacted, but with such conviction, it seemed real. Case 2 or 3 days before. Man claimed land - but OMM claimed. Originally - private farm.

Using land - chasing women away.

OMM brought the case. Judge - held - had no title to land - if he had dispute - not chase people away. Said: land - for OMM, must respect. However, because he was so unconscious about the new society - way to behave, they would not apply any penalty - but give him a chance to understand.

About 60 people attended, many women. Joined in discussion - made suggestions. An older woman brought the complaint. [Everywhere - TPop. - we saw women, but they did not speak. That should be changed].

Even the dependant took part.

After - cultural activities for all. Judges were all peasants.

Narrative: 2 cases. Much poorer, fewer people. Was an actual day of Trib.

Case 1: Garbage man a trader (Indian).
Latter tried to get some to take away.

He, shopkeeper - went to Responsavel - who was a witness. Rubbish-collector - claimed was violence. Said: tore clothes to shreds.

Couldn't accept necessarily.

Voted: Condemned shopkeeper to buy a new shirt & trousers, a rubbish coll. to work 5 days for the Admin.

Aldeia communal. Judge asked if all were satisfied. Said yes.

Case 2: W went to have radio repaired
2 M

Her was ready first - he got angry because his wasn't ready - took her.

She brought the case - sat with repairer. Then called taker of radio.

Much discussion. Complicated case.

Called for comment - people did.

Result: Taker, was told to fetch radio.

Desapp. ^{in trash} We waited. He came back & was

about to hand over to W. Judge stopped

- called to table - to check if all right.

Switched on: atmospheric, listened seriously. Went from taker to repairer, to judge to the woman.

People - after 5 mins. - ignored us.
Asked people to stand up again - when
judges came in. They were puzzled at
first. Very very helpful. Very patient
with us. So absorbed in Trib. - didn't
pay attention to us.

V. good impression re gov. justice -
v. wise. My fear was that local
people might be too
~~Open prison~~ subjective, but what I
saw was wise decisions.

We visited an open prison in Kampala &
(Rex Centro Presonal) - Zona Semi
Open. Homicide & sexual violence.
Teacher - violated pupil: teaching
FREL - funds - pol. classes.
Witchcraft - distilled liquor - hut
burnt - child died.

V. impressed - none tried to escape
since started. Good work in the field.
Cultivating. Looked happy. Pol. training -
discipline - good
~~Good for they~~ - for prisoners -
for everyone -
one of our drivers could have done
with some disc.

We in Denmark - need new ideas -
our pol. system is so different - not
easy to adapt. Many people want
more comm. particip., redue. rather
than vengeance. But we are so used
to intellect, prof. judge - would require
much to change people's minds.

The film - will teach people about
condits. in Moz., but also raise questions
about the legal system in Denmark itself.
