# 3. Plenary Commission on Women in the ANC

In addressing the all-important question of the position of women in our Movement in 1981, Cde President, O.R. Tambo said :-

"If we are to engage our full potential in the pursuit of the goals of our revolutionary struggle, then, as revolutionaries, we should stop pretending that women in our movement have the same opportunities as men. There is little evidence of it......On the other hand, women in the ANC should stop behaving as if there was no place for them above the level of certain categories of involment. They have a duty to liberate us men from antique concepts and attitudes about the place and role of women in society and in the development and direction of our revolutionary struggle."

He further advocated for an intergrative approach on gender issues when he said that the mobilisation of women is the task, not of women alone, but of all of us, men and women alike, comrades in struggle.

with this background in mind participants are invited to undertake an in-depth examination of the situation of women in the ANC; to evolve an intergrative approach on gender issues and to develop recommendations which will ensure increased women's participation in ANC structures and help advance the emancipation/development of women.

Deliberations will be informed by a report on the organization of the work of the Women's Section; a baseline survey report on the situation of women in ANC departmental work, but most of all by a candid exchange of views.

# 4. Plenary Commission on Children

Since the Soweto uprising in 1976, black children have suffered unprecedented child brutality at the hands of the South African regime. Numerous children have been arrested, imprisoned, tortured and murdered by police in an attempt to suppress their anger and frustration at the system of apartheid.

The post-apartheid constitution undertakes to protect the rights of the child.

Participants are invited to give serious consideration to the situation of children in South Africa and to develop more detailed recommendations for their welfare including constitutional protection. Special attention should be paid to further improvement of the welfare of children in exile.
