

- 9. 9.1. 2(h) Is there any reason for using "will" rather than "shall"?
 - 9.2. Here we refer to a <u>Bill of Rights</u> based on the <u>Freedom</u>
 Charter.
 - Quare: 1. Does our statement of principles avoid incorporating what would amount to items in a Bill of Rights based on the Freedom Charter?
