

ANNEXURE TO CHARGESHEET.REGINA versus: JAMES ANDREWS and others.

(hereinafter referred to as the Accused)

THAT the accused, the one, the other or all of them, are X
guilty of the crime of Public Violence.

IN THAT during the period 9th to 10th November, 1959 and at X
Paarl in the district of Paarl in the Regional Division of
the Cape Peninsula, the said accused, with divers other
persons whose names are to the Prosecutor unknown, did
wrongfully, unlawfully and riotously assemble and gather
together a crowd of persons with intent by violent and forcible
means to disturb and endanger the public peace and security
and by such means to invade and interfere with the rights
of the people therebeing or there carrying on business and
to make a riot and affray and by the said means to assail
and set at defiance the authority of the Police and others
in public authority there established to maintain law and

by marching ^(w) (and with the assembled crowd through the streets of
Paarl; by threatening, and attempting to damage, burn and
destroy the premises and other property, of divers people
there being or there carrying on business; and by actually
damaging, burning and destroying certain premises and other
property there situate or there being; of all of which the
following are particulars, to wit:-

(2) (a) By assaulting and injuring or threatening to assault

and other weapons; including firearms.
