NADEL NATIONAL ANNUAL GENERAL MEETING

The rapidly developing negotiations process leading to the adoption of the first democratic Constitution in South Africa has serious and interesting implications for ourselves and our country. Nadel members have been directly involved in the process at a number of levels, and Nadel itself has a continuing leading role to play in contributing to the drafting of the Constitution, interim legislation and the determination of the future legal structure.

These activities and issues will be fully discussed and policy adopted at forthcoming Annual General Meeting being held in Pietermaritzburg from Friday 31 July 1992 to Sunday 02 August 1992. 

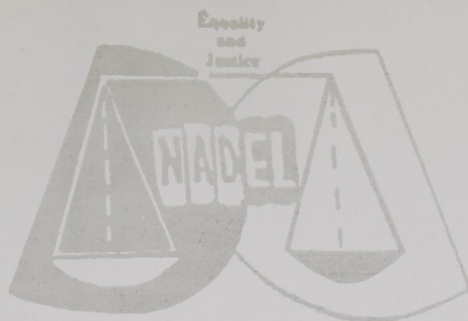
