WORK PROGRAMME

The Community Law Centre at the University of the Western Cape seeks to develop specific policies and resolutions which will form a foundation for children's rights both in the impending constitutional negotiations and in future legislation and decision-making within a democratic South Africa. The Centre has undertaken to hold an International Conference on Children's Rights in early June 1992. In preparation for this conference, the following work plan has been developed. This two-part programme will enable the Centre to devote its primary energies to the research and conceptualisation of detailed policies in certain areas. Other topics will be brought forward to the community and children's rights advocates in the sphere of workshops and consultations. The Centre will publish brief community-oriented information pamphlets following each of these workshops. Simultaneously, the Centre will be engaged in ongoing consultations and preparations for the conference. Following the conference, the Centre hopes to present concrete policies on the rights of children in a new South Africa.

LONG-TERM RESEARCH AND FUBLICATIONS

Brigitte Mabandla and Michelle Morris will be responsible for the primary and empirical research of the following substantive papers to be presented both at the conference and to be utilised in the NCRC situation analysis.
