## **COUNTING CENTRES AND IFP BALLOTS**

This handout that follows is from the IEC. Our summary on the first two pages tries to simplify the key things.

### **1. PARTY AGENTS**

Party agents are allowed to observe the three key parts of the process:

- a) receipt of ballot boxes
- b) reconciliation of ballot papers
- c) four counting tables

### **2. IFP STICKERS AND VOTES FOR IFP**

**WHEN IFP STICKER OR PRINTING APPEARS ON THE BALLOT:**

- a) If a ballot has an IFP sticker on it it is valid (can be counted) unless the sticker blocks the NP space so much that you cannot read the name or that the voting block is very small.

**The People Shall Govern!**

b) If the IFP sticker is stamped with the voting station stamp it is still a valid ballot.

c) If the IFP sticker is printed on the ballot it is valid as long as it has the voting station stamp at the back. This would be the case with the extra ballots that were printed inside SA on Wednesday.

## **BALLOT PAPERS WITHOUT IFP STICKERS (IRREGULAR BALLOTS)**

Some of these will be counted (valid) and some will not (invalid)

### **VALID**

a) a ballot paper without the IFP sticker which has been properly marked for another party and has the stamp at the back is valid and will be counted as "Irregular Valid" in a column that has to be added to the tally form.

b) A ballot with IFP or Buthelezi written on the ballot paper is valid, even if there is no X, it will be counted for the IFP as "irregular valid" The stamp must be on the back.

c) A ballot with IFP or Buthelezi written on it which has a clear X or mark next to another party will be counted for the party that is marked. The stamp must be on the back.

### **INVALID**

**ANY OF THE ABOVE WITHOUT THE STAMP ON THE BACK WILL BE "INVALID IRREGULAR" AND WILL NOT BE COUNTED FOR ANY PARTY.**

All the irregular ballots must be kept separately from other ballot papers.

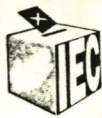
