WILL DO WHATEVER CHIEF INSTRUCTS ME TO DO ABOUT CONFERENCE BUT MY RECOMMENDATION IS THAT THE PROPOSAL SHOULD BE SQUASHED DISCREETLY EVEN IF WE ARE NOT TO PARTICIPATE. PLEASE PASS ON MY VIEWS TO PRESIDENT. SUPPLY DETAILS ABOUT INHOUSE SEMINAR 1 TO 4 MARCH URGENTLY. HAVE MANY SUGGESTIONS CONCERNING FUTURE OF CONSTITUTION COMMITTEE AND WILL WRITE AT LENGTH. CONVEY REGRETS TO PRESIDENT AND COMRADE JACK.
