The Natal Church Leaders Group - a mission statement

The Natal Church Leaders Group is an informal and autonomous association of the recognised leaders of the following churches operating in the province of Natal:

Church of the Province of Southern Africa Methodist Church of Southern Africa Evangelical Lutheran Church in Southern Africa Presbyterian Church of Africa Roman Catholic Church United Congregational Church of Southern Africa

It is hoped that the ecumenical base of the group will broaden to include other churches in the region.

The NCLG was formed on 7 May 1988 in response to the crisis in the Province arising out of the political violence that by the end of 1990 had taken over 4000 lives, destroyed immense amounts of property and turned thousands of families into refugees.

The Group meets on a regular (usually monthly) basis and its membership comprises the leaders of the above mentioned churches. In addition the NCLG is able to call on a number of advisors, facilitators and consultants to assist in its deliberations and work. Included among these are representatives of the regional Councils of Churches in Natal, the Vuleka Trust, Diakonia, PACSA, the South African Council of Churches, and Standing for the Truth Campaign. Any decisions made are by consensus and in no way inhibit the leadership of the particular churches from acting individually as they see fit.

The NCLG sees its mission as being a body through which the Church leaders can act decisively in crisis situations, through informing themselves of the issues underlying the crisis, supporting each other in collective or denominational action, and through collective attempts at mediation, peacemaking, crisis relief, solidarity with the victims of violence, and prophetic challenge.

Among the variety of interventions open to the NCLG are the following:

* Offers to mediate and facilitate peace talks between warring parties.

- * Negotiating with the state and challenging it to take appropriate action to help resolve the conflict and its causes.
- * Informing clergy and laypeople of the issues that underlie the violence so that more informed decision making may be made by Christians at every level of involvement.
- * Training in conflict handling.
- * Supporting each other in crisis situations.
- * Supporting appropriate interventions by other bodies aimed at addressing the crisis.
- * Acting through immediate responses, pastoral visits and crisis relief (usually through the Natal Crisis Fund) to bring care and hope to the victims of violence.
- * Planning for reconstruction when the violence ends.

1. Chairmanship

It was agreed that Dr Z de Beer should chair this and the next meeting, and that future MC and DMC chairpersonship should be determined at the next meeting of the DMC.

3.3 Current Applications

3.3.1 Political Parties/Organisations

- 3.3.1.1 It was agreed that work should begin immediately on the gathering of information on each of these organisations in order to establish guidelines on qualifications for inclusion in the CODESA process.
- 3.3.1.2 The meeting agreed that these guidelines should be tabled at the next DMC meeting.

3.3.2 International Organisations

It was agreed that these organisations should be advised that only the representatives of governments and multi-lateral organisations such as the United Nationas and Commonwealth were accorded observer status at CODESA 1, and that no final decision has yet been reached on the question of observers at CODESA 2.

3.3.3 Sundry Interest Groups

It was agreed that these applications should be declined on the understanding that such interest groups will be welcome to submit representations to the five working groups on matters relevant to their terms of reference.

4. Security

It was agreed that Colonel Venter and Mr M Shaik should be requested to attend the DMC meeting on 20 January in order to report to the Committee on this matter.

5. Media

It was agreed that the Secretariat and its staff will continue to attend to routine announcements and that the members of the Media Subcommittee should be informed of the MC's decision not to appoint a full-time media liaison officer. It was further agreed that the Secretariat may call upon the Media Subcommittee members for assistance if and when necessary.

6. Working Groups

- 6.1 It was agreed that each Working Group should be convened at its first session on 20 January by a member of the DMC. Thereafter, recommendations will be made by the DMC regarding an appropriate mechanism for the chairing of Working Group meetings.
- 6.2 DMC members are distributed amongst Working Groups as follows:

It was agreed that copies of the request from this group for a meeting with representatives from CODESA should be sent to all DMC members in order to inform a decision in this regard, facilitated by the Secretariat, at the next meeting of the DMC.

8. Tasks of the Secretariat

It was agreed that a list of Secretariat duties should be made available to all DMC members at the committee's next meeting.
