### WORKING GROUP 1

#### SUB-GROUP 3

BOPHUTHATSWANA'S SUBMISSION ON THE RE-STRUCTURING/-RE-CONSTITUTION OF THE BOARDS OF CONTROL OF PUBLIC BROADCASTERS IN THE TBVC STATES

### INTRODUCTION

During the meeting of this sub-group on Tuesday 21 April 1992, it was twice suggested that whenever and wherever reference was made to the SABC, any discussions thereof be afforded a generic meaning to include the TBVC states. Bophuthatswana wishes to place on record the following points which represent the position Bophuthatswana has taken on this matter.

## INCLUSION/NON-INCLUSION OF TVC

We leave the question of the TVC states to each of those states to determine for themselves. This is because we respect their severeignty, political decision-making ability and self-determination. Bophuthatswana believes that in keeping with the foregoing, each one of the TBVC states should be allowed to decide for themselves what is in the best interests of their citizenry.

### BOPHUTHATSWANA'S POSITION

The Government of Bophuthatswana is aware of the vexed nature of this matter. We believe that the sub-group can only do justice to the question by giving it far more attention than has been done. The suggestion to include Bophuthatswana's Broadcasting Corporation in the discussions that essentially centred around the SABC is evidence of the cursory manner in which this sub-group has attended to this matter.

In the view of the Government of Bophuthatswana, this sub-group cannot and should not hasten to agree or decide, even if only in principle, on matters that will impact on the sovereignty and future of Bophuthatswana. A specific Working Group at CODESA has been charged with the duty to negotiate, discuss and if possible agree on the constitutional future of the TBVC states. It is only in the light of decisions and/or agreements arrived at in/by that Working Group that any decisions/agreements impacting on institutions in Bophuthatswana can be taken.

In particular and in summary, Bophuthatswana does not accept nor agree to any decisions taken by this sub-group purporting to bring Bophuthatswana Broadcasting Corporation under the auspices of any authority, body or commission established pursuant to the decision to re-constitute or re-structure broadcasting in South Africa. In this regard Bophuthatswana keeps her options open.
