DEAR MR. WEBB.

RE: POLITICAL PRISONERS OF THE A.N.C.

WE ARE VERY CONCERNED ABOUT ABOUT THE CURRENT DEVELOPMENTS IN SOUTH AFRICA TO A NEW DEMOCRATIC SOUTH AFRICA. WE ARE THE EX-A.N.C. DETAINEES WE WERE HELD IN THE CONCENTRATION CAMPS OF THE A.N.C. / S.A.C.P. IN THE COUNTRIES LIKE ANGOLA / ZAMBIA / TANZANIA AND UGANDA. WE WERE RELEASED ON 17-AUGUST 1992, FROM UGANDA. WHEN WE CAME BACK TO OUR MOTHERLAND WE WERE A GROUP OF 32. ALL OF US WE WERE CALLED ENEMY AGENTS SO CALLED GOVERNMENT SPIES WITHOUT ANY PROOF. AS A RESULT WE DECIDED TO FORM THIS COMMITTEE TO INVESTIGATE MORE ABOUT THE ALLEGATIONS THAT WERE MADE BY THE A.N.C. THIS COMMITTEE IT CONSIST OF OF EX-A.N.C. DETAINEES, PARENTS OF THOSE WHO DIED IN EXILE AND THOSE WHO DISSAPPEARED UNDER THE A-N-C- NOTORIOUS SECURITY DEPARTMENT (IMBOKODO) A GRINDING STONE. TODAY WE ARE WONDERING WHY THE CODESA IS LESS

CONCERNED ABOUT OUR PLIGHT AS THE SOUTH AFRICAN CITIZEN, IS THE CODESA AWARE THAT, BY IGNORING US, THAT THEY ARE BUILDING A BANDITS OR REBELS IN SOUTH AFRICA, WE ARE SAYING THIS BECAUSE OUR COMMITTEE MEMBERS ARE EX-MIK SOLDIERS.

WE ARE FOR PEACE IN SOUTH AFRICA NOT FOR ANY KIND OF VIOLENCE. WE HAVE APPLIED IN THE CODESA 1. AND WE WERE NOT INVITED, WE HAVE APPLIED AGAIN

ON THE 24-2-92. AND WE WERE TOLD BY MR. J. DALLING WHO WAS THEN A CHAIRMAN OF WORKING GROUP 1 TO SUBMIT 29 COPIES OF OUR PAPER, AND HE EVEN SAID HE WILL KEEP IN TOUCH WITH US. AND WE HAVE DONE ALL HIS REQUEST, AND WE WERE NOT AWARE THAT HE WAS FOOLING US. AND WE ARE VERY MUCH AWARE THAT, CODESA IS DOMINATED BY THE A.N.C. S.S.A.C.P. MORISO PEOPLE WHO WERE INVOLVED IN COMMITTING CRIMES IN EXILE, PEOPLE LIKE JOE NTLANTLA WHO IS A HEAD OF THE A.N.C. SECURITY DEPARTMENT, AND JACOB ZUMA WHO IS A CHIEF OF INTELLIGENCE OF THE A.N.C. AND JOE MODISE ARMY COMMANDER OF THE MK.

RONNIE KASRIL AND PHINEAS MADUNA WHO WAS INVOLVE IN THE A.N.C. KANGAROO COURTS IN ANGOLA ALL THESE PEOPLE ARE THE WAR CRIMINALS THEIR HANDS ARE FULL OF BLOOD, THEY DESERVE TO BE PUNISHED. SIR THIS IS OUR THIRD ATTEMPT TO SEEK A PLATFORM IN THE CODESA, LAST YEAR WE WROTE TO DR. ZAC DEBEER, 2ND TIME TO MR. J. DALLING THEY BOTH FAILED TO TAKE OUR LETTERS TO THE MANAGEMENT COMMITTEE.

NOW ITS THE LAST ATTEMPT, AND IF WE FAIL THIS TIME, WE WILL APPLY NEW METHODS THAT WILL MAKE CODESA TO

WE WOULD LIKE OUR CHAIRMAN TO PRESENT A VERBAL SUBMISSION CONCERNING POLITICAL PRISONERS ON THE CODESA 2.

THE FOLLOWING SPECIFIC POINTS WILL FORM THE BODY OF OUR PRESENTATION.

1. THE AFRICAN NATIONAL CONGRESS' MILITARY WING MK, CLAIM TO BE A LIBERATION ARMY. THEREFORE THEY SHOULD BE PROSECUTED FOR THEIR CRIMES.

2. AS A RESULT OF MK'S ACTIONS, IN THE FORM OF TORTURE, INCARCERATION, MURDER TO NAME BUT ~~ONLY~~ A FEW, WE HAVE SUFFERED GREATLY. THE A.N.C. SHOULD PAY COMPENSATION TO THOSE FAMILIES WHO HAVE BECOME THE VICTIMS OF A.N.C. ATROCITIES FAR WORSE THAN ANYTHING IMAGINED IN SOUTH AFRICAN PRISONS.

3. MANY OF OUR COMRADES LIE BURIED IN FOREIGN COUNTRIES WE WANT THE A.N.C. TO BRING HOME OUR DECEASED, SO THEY MAY REST IN PEACE IN THEIR LAND OF ORIGIN

\* WE KNOW THAT THE A.N.C. ARE STILL HOLDING POLITICAL PRISONERS BEYOND THE BORDERS OF SOUTH AFRICA. WE FEEL THAT THE SOUTH AFRICAN GOVERNMENT HAS AN OBLIGATION TO CARE FOR ITS CITIZENS.

WE THEREFOR DEMAND THE UNCONDITIONAL RELEASE OF ALL PRISONERS HELD BY THE A.N.C.

THE SOUTH AFRICAN GOVERNMENT MUST TRY AND ASSIST IN SECURING THE RELEASE OF THESE PRISONERS.

THE HELP OF THE UNITED NATIONS AND THE INTERNATIONAL COMMUNITY, MUST ALSO BE SOLICITED TO EXECUTE THIS TASK. WE ARE ALSO DEMANDING THAT WE SHOULD BE GIVEN AN OPPORTUNITY TO POINT OUT THE SHALLOW GRAVES

IN ANGOLA AND TANZANIA.

5. WE ARE ALSO CALLING ON THE SOUTH AFRICAN GOVERNMENT TO ASSIST IN OBTAINING THE RELEASE OF KATIZA CEBEKHULU, PRESENTLY BEING HELD IN ZAMBIA AND ALSO A WITNESS IN THE TRIAL OF WINNIE MANDELA.
6. WE ARE ALSO CALLING FOR AN INQUEST ON THE DEATH OF SPHIWO PHUNGULWA WHO WAS GUNNED DOWN IN TRANSKEI 1990. PHUNGULWA WAS ONCE A BODYGUARD OF CHRIS HANI, AND WE BLAME THE A.N.C. AS DO OTHERS IN RECOC. WE ALL SAY THE MK LEADERSHIP ORDERED THE MURDER BECAUSE PHUNGULWA KNEW TOO MUCH, AND WANTED TO TALK. AND GENERAL HLOMISA HE NEVER TOOK ANY ACTION ABOUT THE ASSASSINATION OF PHUNGULWA.

WE HOPE SIR, YOU WILL INFORM US VERY EARLY.

THROUGH THE POWER OF GOD  
WE WILL WIN AND BRING THEM BACK  
FROM THE FOREIGN LANDS.
