

I acknowledge receipt of a facsimile letter from yourself
received by me on the 10th March, 1992.

On the 5th March, 1992 I received a facsimile from you enquiring
as to whether I would be willing to make an oral submission to
your sub-committee. I replied per facsimile dated 6th March,
1992.

Your latest letter asks me to communicate with traditional
leaders and to let you know who will present evidence for "my
region and which day and time will suit the group". I am wholly
unable to understand this request. I am prepared to give oral
evidence before your committee as an expert on the matter of
