- 2. (a) Is it alleged that Accused No. 3 considered or/...

or planned any of the acts referred to in paragraph 3 of the Schedule?

- (b) If so, particulars are required of the time when and place where he is alleged to have done so.
- 3. (a) Is it alleged that Accused No. 3 possessed any of the explosives referred to in paragraph 5 of the Schedule?
 - (b) If so particulars are required of the said explosives, and of the time and place of the alleged possession.
 - (c) The names are required of the other persons alleged to have been in possession of the said explosives, with particulars of the time and place of the alleged possession.
- 4. (a) Is it alleged that Accused No. 3 prepared time bombs or shape charges?
 - (b) If so, full particulars are required, including relevant particulars of time and place.
- 5. (a) Is it alleged that Accused No. 3 organised or was a member of any cell?
 - (b) Is so, particulars are required of the membership of such cell, at all relevant times, and of the acts or activities rereferred to in the indictment which the said cell is alleged to have carried out.

Particulars are further required of Accused No. 3's alleged activities in connection with the said cell and his date of joining and period of membership.

- B. Ad the Alternative Charge.
- 1. (a) When or alternatively by what date is it alleged Accused No. 3 became or remained a member or an active supporter of the said organisation?
 - (b) In what manner is it alleged that he became or remained a member or an active supporter?
- Particulars are required of the facts upon which the State relies in support of its allegations concerning the aims and objects of the said organisation, including copies of any relevant documents.
