

which was written a list of names. Well I told them  
that I don't know anything about it.

I have been working in ~~Cape Town~~ since 1949. Since 3/8/61 I am employed at the Jewish Aged Home Buitenkant street Cape Town. I reside on the premises.

Towards the middle of 1962 a bantú male from Langa unknown to me came to our quarters at the home and called a meeting. Quite a nice lot of us working there were present at this meeting.

This man from Langa started off by telling us that he had come to tell us what is going on outside. He told us that all African men, that is bantú men must join the P.A.C. Someone asked him what the aims of the P.A.C. was. He said we want to be equal to the whites. One of my fellow men told him that we have seen a lot of things happening but how can we get equal to the whites. He said we will talk to them and if they do not agree we will use violence. Someone then wanted to know how can we fight the whites, without guns and machine guns.

He said every African man must try to get a weapon.

wherever possible. He said that he knows we can't have guns but every man must have a piece or knife. A question was put to him, How can a man fight a gun with a piece and a knife. He said that every man must do his best because as soon as P.A.C. starts fighting the whites, the whites will fight all black men whether he is a member of P.A.C. or not.

He carried on by telling us that he knows all bantus living in town do not want to go with P.A.C. but we must understand that whenever there is a chance in town or when we come in Langa or Nyanga, it will be too bad for us. All those who do not want to join will be killed.

On a question put to him he said that we can join by paying 25<sup>c</sup> subscription to him, so he will send someone to collect it or appoint someone amongst us to collect the fees. We wanted to know what the money is going to be used for. He then got cross and said that nothing can be done without money. He used an example of the Aged Home

When we are working and said that money was first collected to build the place.

Some more questions were put to him and then he was cross and said he wants to know who wants to join because those who do not join will be killed by those who join.

Some of the men then walked out but all of us who stayed behind took out 25<sup>c</sup> each and paid him. He wrote down our names on a piece of paper. He spoke to those walking out in him and told them that they are marked. Someone asked him what he means by that. He said you will be killed.

Of the men who joined at that meeting I remember the following.

- ① R. Makalima. (left employ)
- ② L. Maklakati. (left employ)
- ③ Myself.

After we had paid our fees he closed the meeting and sat talking to us about things in general.

He did not give us receipts for our money.

There was no committee formed at that meeting.

He said that very soon we will speak to the whites and tell them that we want to be equal to them. If they don't agree we will use violence.

A few months after the first meeting there was another meeting in our quarters, held by the same man.

I was not present at this meeting because I was out visiting my wife. I heard about it when I came back the next day. The men were talking about this meeting. I do not know what transpired on this meeting.

Apart from the names already mentioned I have also heard that Alphius Masoka had joined and paid the 25c

The two lists of names found in my belongings do not refer to members of P.A.C. The one on brown paper refers to persons to whom I sold tickets for a concert. The other one was a collection to pay a witch doctor to tell us who stole some articles in our quarters.

I have heard and learnt that P.A.C. and Pops is the same organization. ~~by "Pops"~~
