The exact dates, times or places are to the prosecutor unknown except insofar as it will inter alia be alleged that all the accused attended a P.A.C. or Poqo meeting during the lunch break about September, 1962, at the Brooklyn Chest Hospital.

#### Question 2:

It will be alleged that the offences were committed at the same place in the jurisdiction of this Court at approximately the same time and that the accused may be charged together by virtue of Section 12(6)(a) of Act 44 of 1950.
