- 1.1 Whereas CODESA has been convened for purposes of transforming South Africa into a real and true democracy;
- 1.2 Whereas it is accepted that all the people of South Africa ought to be accorded the right to contribute to the negotiating process of CODESA on a meaningful basis;
- 1.3 Whereas CODESA is a body made up of political parties, political organisations and administrations;
- 1.4 And whereas it is necessary to consider, report on and recommend on whether the King of the Zulus and other traditional leaders should be given the opportunity of participating in the negotiating process of CODESA in whatever manner;

### **2. NOW, THEREFORE:**
