I would like to invite you to a small informal discussion at the Urban Foundation on the role, function and importance of the "satellite" negotiating forums. As you know, a number of forums have been, or are in the process of being established (e.g. transport, housing, electricity, economic, education) and there is talk of other areas of policy forum-making (e.g. land, local government, health, rural development).
